### INSTRUCTIONS

Drivers who are employed in the farm-related service industry may be eligible for the issuance of a restricted Class B or C commercial driver license. This restricted commercial driver license can only be issued for a maximum period of up to 180 days within a 12-month period and limits the driver to within 150 miles of the employer's place of business or the farm currently being served. Please review the following requirements. If you meet these requirements, certify below and have your employer complete the back of this form.

- No driver license suspensions, revocations, disqualifications, or cancellations of any kind;
- No convictions in any type of motor vehicle for driving under the influence of alcohol or drugs, leaving the scene of an accident, or committing any felony involving a motor vehicle;
- No convictions whatsoever in any type of motor vehicle for serious traffic violations, i.e., speeding, at 15 miles per hour or more above the posted limit, reckless driving, improper or erratic lane changes, or following too closely; and
- No convictions in any type of motor vehicle for accident-connected traffic law violations, and no record of at fault accidents.
