Proof of financial responsibility is required before an inspection may be conducted. Vehicles equipped to use CNG as a fuel must provide proof of the system's expiration date as a prerequisite to inspection.

Inspection items for passenger cars or light duty trucks are as follows:

One Year Safety	\$7.00
Two Year Safety (New Vehicles Only)	\$7.00
Commercial Windshield	\$40.00
Commercial Trailer	\$40.00
Trailer/Motorcycle	\$7.00
Moped	\$0.25
OBDII Inspection	\$18.50
TSI Inspection	\$18.50
Emission Test Only	\$11.50

If a vehicle is rejected on the initial inspection and the statutory fee is charged, the vehicle must have required repairs completed and presented to the initial station within 15 days for one free reinspection.
