TCIC AUDIT FAQs

Texas Driver License Photos

DL photos cannot be permanently stored in agency files, CADs or RMS systems.

TLETS OPERATING MANUAL

Texas Driver License System

Access, use of, and disclosure of digital images obtained via the TLETS connection from DLS (Driver License System) is for law enforcement purposes only. The User Agency shall not permanently store or maintain a database of digital images obtained from DLS. This includes incorporation of driver license photos obtained from the Department into a local agency's records management or case management system. The User Agency shall not provide the driver license digital image to any third party.

Out-of-State Driver License Information

Driver license information from other states may or may not be classified as public record information. Any non-criminal justice individual or agency requesting procedures to obtain DL information from other states should be directed to contact the drivers licensing agency of that specific state.

Dissemination of Criminal Justice Information – Including DL and Registration

The policy of the Texas Department of Public Safety is that TLETS system-derived information is used only for criminal justice purposes by criminal justice employees. It is important to note, that the Department of Public Safety holds information derived from the TLETS network, such as driver license data and vehicle registration data, in the same regard as CJII (Criminal Justice Information) and requires agencies to afford it the same level of protection as required for CJII.

Electronic Records Management System (ERMS)

An ERMS is defined as any electronic database, including an electronic warrant database. Agencies must conduct appropriate follow-up to resolve discrepancies identified during synchronization and cross-checks. All electronic processes must be approved and accepted by the CJIS Systems Agency and be in compliance with CJIS security and NCIC policies.

Compliance with CJIS and NCIC policies may be achieved through electronic or manual processes.

If you attach AM (administrative messages) to your case files, the information must be kept as private and secure as it is in the TLETS/NIlets databases and computers. You must have ways of protecting the data from unauthorized users.

COMMUNICATING WITH COMMERCIAL AND MEXICAN DRIVER LICENSE DATA

Effective 03/20/2015, access to commercial driver data and Mexican driver license and vehicle registration information over the Nlets network has been restored thanks to a recently completed project in partnership with the Federal Motor Carrier Safety Administration (FMCSA).

Users may retrieve commercial driver license data (DQ) by checking the 'Commercial License (CDL)' or 'Commercial DL (CDL)' box on the Omnixx DQ, QUERY, RSDW or RSDWW form; interface systems may send the DQ to destination 'CL' to retrieve commercial driver license data. 
TDEx & N-DEx

Help Is On the Way

As of this writing, the Texas Data Exchange (TDEx) Bureau has had to postpone all training on the National Data Exchange (N-DEx) system. We are proud, but sad, to say that both of our trainers have promoted to other positions within the Texas Department of Public Safety. That both trainers promoted to positions of management is a testament to the value of the person and their abilities. They will continue to do great things in their new positions, but they have left a void in the TDEx Bureau.

But help is on the way! We are in the process of screening applications in the hopes of finding new trainers that can provide the level of training knowledge and expertise that our N-DEx users have come to expect. Once the applications are screened, we will follow up with oral interviews with those we feel can help fill the void. At that point, we will select the two most qualified applicants and prepare them to provide our users with quality trainings and expert knowledge.

As we go through this process, we ask our users to take advantage of the Computer-Based Trainings (CBTs) that are available to them in N-DEx. These can be found in the upper right hand corner under the Resources drop down menu.

CRIMINAL JUSTICE INFORMATION SYSTEM SITE

The CJIS site is provided by the Texas Department of Public Safety to assist counties in managing their Computerized Criminal History (CCH) information and to manage CJIS users for respective entities.

The Entity Administration section allows a local representative to manage CJIS users for their entity. The functions that are currently available are:

- Approve/Deny users for CJIS access,
- Reset passwords,
- Remove users who no longer need access.

The Criminal Justice Information System (CJIS) Field Support Unit has been short-staffed for several months now. We currently have three Field Representatives covering all nine of the CJIS Regions. We are working to interview and hire new Field Representatives. Please be patient as we go through the interview/hiring and training processes.

Region 2, Region 8 and Region 9 are currently covered by the three Field Representatives. Counties in the remaining regions that are below the 90% Completeness have been assigned to one of the three CJIS Representatives. As the Grant process is ramping up, we are concentrating on those counties that need the most assistance to reach the 90% Completeness requirement for grant requests.

If your county is in one of the uncovered regions and is above 90% Completeness in both Juvenile and Adult reporting, please contact the main CJIS Field Support Unit or the Supervisor, Cassandra Richey, for any questions you may have about reporting. Please be sure to leave a message if your call is not immediately answered. If you are in need of training, please send the request to the main CJIS Unit email and we will schedule the training as time allows.


