Assist the owner in completing and submitting the TCEQ 30 day construction notification form.
Notify the local TCEQ office 24-72 hours prior to starting the decommissioning.
Remove the existing Stage II hanging hardware on two (2) unleaded dispensers.
Furnish and install standard hanging hardware on two (2) unleaded dispensers.
Disconnect and capped the Stage II vapor return pipe at the dispenser.
Disconnect and remove the HEALY Mini-Jet on the STP at the AST.
Furnish and install new product pipe where the Mini-Jet is removed.
Perform the required two (2) TCEQ Stage I tests and one (1) product line test.
Complete and return the TCEQ submittal form.
Replace the defective mechanical leak detector on the STP.

The Contractor represents and warrants that the Department is not prohibited from entering into this contract with the Contractor under Section 2261.252, Tex Government Code, adopted by SB20, 84th Legislature, Regular Session. If the Contractor(s) representation and warranty is incorrect and the Department was prohibited from entering into this contract with the Contractor under those provisions, this contract is void.
