# Key Points



## Today

- Two separate Marginal Risk areas of isolated severe thunderstorms...one over the TX panhandle/E NM and one over NE AR...both with damaging winds and large hail as the primary impacts.

## Friday

- Marginal Risk of severe thunderstorms over AR...with damaging winds and large hail as the primary impacts.

## Saturday - Monday

- Significant Weather Impacts are not expected

## River Flooding


- Overall slow improvement to continue with temperatures rising and low rain chances
- Moderate river flooding continues over portions of east & southeast TX for the next several days
- Isolated major river flooding over southern OK but will continue steady fall

## Tropical Outlook

- There is a 10% chance of tropical cyclone formation in the SW Gulf of Mexico late Sunday into Monday.

# River Flood Status/5 Day Forecast Rainfall

- Overall slow improvement will continue over east and southeast TX.
- Rain forecast for next 5 days will not lead to additional rises.
- Isolated major flooding over southern OK but will continue to improve.  
Primarily agricultural impacts






# Tropical Weather Outlook




No new tropical activity is expected during the short term.

10% chance of tropical cyclone formation over the SW Gulf of Mexico.












# Day 2-3 Weather Maps/Precipitation













# 5-Day Precipitation Thu AM - Tue AM




Weather "Threat" Matrix

Green	<p><b>Very Common</b></p> <p>Safety: Rarely a Direct Threat to Life and Property</p> <p>Impact Potential: Typically Results in Little Inconvenience to Daily Routines</p>	<p>Severe: Marginal Risk from SPC</p> <p>Flooding: Minor flooding expected over localized areas</p> <p>Tropical: None</p> <p>Fire Weather: No Watches/Warnings, fuel moisture above 10% or green up active</p>	<ul style="list-style-type: none"> <li>Thunderstorms expected over LA this afternoon; a few may produce winds to knock down a few trees</li> <li>Something that happens almost every day in a particular season such as <u>seabreeze</u> storms in coastal TX</li> </ul>
Yellow	<p><b>Somewhat Common – Happens Frequently</b></p> <p>Safety: Rarely a Direct Threat to Life and Property</p> <p>Impact Potential: Typically Results in Some Inconvenience to Daily Life</p>	<p>Severe: Slight Risk from SPC</p> <p>Flooding: Nuisance flooded expected for a widespread area, or Minor flooding expected over isolated areas</p> <p>Tropical: A weak tropical wave expected to move towards or near any coastline</p> <p>Fire Weather: Red Flag Watches/Warnings and/or SPC outlines enhanced or critical fire outlook</p>	<ul style="list-style-type: none"> <li>2-3 inches of rainfall expected over central AR today and tonight; some minor (brief) street flooding possible</li> <li>Scattered severe storms possible, one or two tornadoes expected, along with reports of strong winds/wind damage and ~1" hail</li> </ul>

Red	<p><b>Rare – Once every 1-5 Years</b></p> <p>Safety: Extensive Property Damage Likely, Life Saving Actions Also will be Needed</p> <p>Impact Potential: Will likely result in Large Disruption to Daily Life</p>	<p>Severe: Moderate Risk from SPC</p> <p>Flooding: Moderate flooding expected over a widespread area (including urban locations)</p> <p>Tropical: A Hurricane expected to move towards or near any coastline</p> <p>Fire: Large areas of critical conditions for 2 or more days, Warnings for 3 or more days, Severe to extreme drought</p>	<ul style="list-style-type: none"> <li>A Category 1 hurricane will be moving towards the NW Gulf in the next few days</li> <li>Widespread severe storms likely, strong tornadoes, widespread wind damage, and destructive hail</li> <li>Large fires ongoing throughout the area with critical fire weather conditions expected to continue</li> </ul>
Purple	<p><b>Very Rare – Once Every 5-10 Years</b></p> <p>Safety: Property Damage Unavoidable, Immediate Action to Save Life will be Needed</p> <p>Impact Potential: Typically Results in Long-Lived Widespread Major Disruption to Daily Life</p>	<p>Severe: High Risk from SPC</p> <p>Flooding: Major flooding expected over a widespread area (including urban locations)</p> <p>Tropical: A Major Hurricane (Cat3 or greater) expected to move towards or near any coastline</p> <p>Fire: Large area of critical conditions for 2 or more days, Warnings for 3 or more days, Long term (months) of severe to extreme drought</p>	<ul style="list-style-type: none"> <li>A Category 4 hurricane is headed towards the SE LA; major storm surge, flooding and damaging winds anticipated to begin tomorrow</li> <li>Widespread severe storms expected, tornado outbreak probable with long-lived, very widespread and particularly intense storms</li> </ul>
