- Marginal Risk of severe thunderstorms over NE NM and the TX/OK panhandles. Damaging winds and large hail are the primary impacts.

Friday - Saturday

- Significant Weather Impacts are not expected

River Flooding


- Overall slow improvement to continue across the Region but moderate river flooding will persist on the Lower Trinity River in east & southeast TX

Tropical Outlook

- Tropical cyclone formation is not expected during the next 5 days

- Moderate river flooding will persist on the Lower Trinity in east & southeast TX

Green	<p>Very Common</p> <p>Safety: Rarely a Direct Threat to Life and Property</p> <p>Impact Potential: Typically Results in Little Inconvenience to Daily Routines</p>	<p>Severe: Marginal Risk from SPC</p> <p>Flooding: Minor flooding expected over localized areas</p> <p>Tropical: None</p> <p>Fire Weather: No Watches/Warnings, fuel moisture above 10% or green up active</p>	<ul style="list-style-type: none"> Thunderstorms expected over LA this afternoon; a few may produce winds to knock down a few trees Something that happens almost every day in a particular season such as <u>seabreeze</u> storms in coastal TX

Purple	<p>Very Rare – Once Every 5-10 Years</p> <p>Safety: Property Damage Unavoidable, Immediate Action to Save Life will be Needed</p> <p>Impact Potential: Typically Results in Long-Lived Widespread Major Disruption to Daily Life</p>	<p>Severe: High Risk from SPC</p> <p>Flooding: Major flooding expected over a widespread area (including urban locations)</p> <p>Tropical: A Major Hurricane (Cat3 or greater) expected to move towards or near any coastline</p> <p>Fire: Large area of critical conditions for 2 or more days, Warnings for 3 or more days, Long term (months) of severe to extreme drought</p>	<ul style="list-style-type: none"> A Category 4 hurricane is headed towards the SE LA; major storm surge, flooding and damaging winds anticipated to begin tomorrow Widespread severe storms expected, tornado outbreak probable with long-lived, very widespread and particularly intense storms
