Key Points

Today

- Heat index values of 105+ degrees across portions of AR, N LA, S TX
- Scattered showers and thunderstorms, but widespread severe weather and/or flooding is not expected
- A few isolated areas along/near the LA coast could experience locally heavy rain and flash flooding

Wednesday through Saturday


- Scattered showers and thunderstorms will continue through the week, but widespread severe weather and/or flooding is not expected

Tropical Outlook

- No new tropical development expected in the next five days

River Flood Status/5 Day Forecast Rainfall

Rainfall over the eastern portions of the Region will be from accumulated daily rain chances, not all within a short period. Therefore, no significant river flooding is expected.






Tropical Weather Outlook



No new tropical systems expected to develop over the next five days












Thursday's Weather
