Key Points



Sunday - Monday

- Showers and thunderstorms continue over NW TX/SW OK and parts of SE TX.
 - Isolated strong storms with heavy rainfall/flash flooding possible over NW TX/SW OK into central TX.

Tuesday

- Showers/thunderstorms should persist as the upper low moves across FEMA Region 6 but no significant weather impacts are expected.

Wednesday – Thursday

- No Significant Weather Impacts


- Tropical cyclone activity is not expected in the next 5 days.

Five-Day Graphical Tropical Weather Outlook










