Key Points



Monday

- Showers and thunderstorms continue over central TX/OK and southern LA.
 - Isolated heavy rainfall/flash flooding possible with strong storms over central TX into NE OK and along LA coast.

Tuesday

- Showers/thunderstorms should persist as the upper low moves across FEMA Region 6 but no significant weather impacts are expected.

Wednesday – Friday

- No Significant Weather Impacts

Tropical Outlook

- Tropical cyclone activity is not expected in the next 5 days.

Five-Day Graphical Tropical Weather Outlook






Isolated strong thunderstorms with heavy rain/flash flooding over central TX into NE OK and along LA coast.







Scattered showers and thunderstorms across southern portion of Region 6 but no significant weather impacts expected.







Day 4-5 Weather Hazards




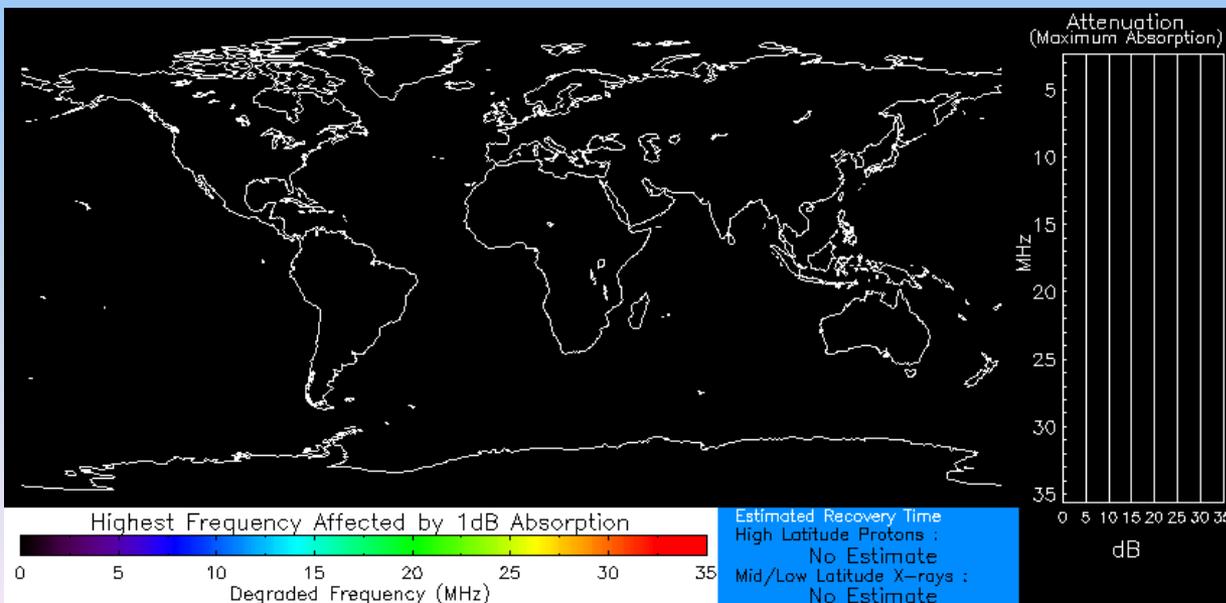
