STATEWIDE CURRENT SITUATION: Governor Abbott issued a disaster proclamation stating that the severe weather and flooding event that began on 06/19/18, has caused a disaster in Aransas, Cameron, Hidalgo, Nueces, San Patricio and Willacy Counties. Water removal operations are ongoing in impacted areas of the Rio Grande Valley. Impacted local jurisdictions have begun damage assessments.

WEATHER (NWS Brownsville): June will close on a hot and breezy note across deep south Texas with afternoon highs ranging from the mid 80s along the immediate coast to above the century mark out west. Expect mostly sunny to partly cloudy skies today.

- 1. Transition to Recovery
- 2. Collection of local jurisdictional damage assessments
- 3. Collect and disseminate accurate incident information to improve decision-making
- 4. Accurately track incident costs associated with assigned resources for cost recovery

Texas Department of Transportation (TxDOT): TxDOT has resumed normal operations and continues to support as needed. Currently there are two state highway sections affected by cave in. One highway section is fully closed due to flooding. TxDOT is supporting the pumping operations and the pump staging area. Texas Department of Public Safety (DPS) Texas Division of Emergency Management (TDEM): Field Response continues to work with local, state, and federal agencies, as well as volunteer partners as the transition to recovery have begun. The State Operations Center (SOC) has processed 50 State of Texas Assistance Requests (STARs) and 85 actions for the June Severe Weather Incident.

Texas Commission on Environmental Quality (TCEQ): Regional staff continues to assess drinking water and wastewater facilities in impacted areas to determine operational status and address any significant incidents.

Texas A&M Forest Service (TFS): TFS is providing one person for the planning component to DDC 21. Three IMT members remain assigned to support operations from 06/26/18 to 06/28/18.

Department of State Health Services (DSHS): DSHS is coordinating with local jurisdictions who have requested assistance with mosquito / vector control.

Texas Health and Human Services Commission (HHSC): HHSC Regional Administrative Services (RAS) has provided three staff members to assist with Individual Assistance Preliminary Damage Assessment (IA PDA) in Cameron and Hidalgo Counties.

American Red Cross (ARC): Continues to support shelter operations in the impacted RGV areas and distributing emergency supplies via ERV's in Jefferson and Orange Counties.

The Salvation Army (TSA): Emergency shelter stood up in McAllen / Hidalgo County. TSA is supporting three shelters (in Weslaco, Pharr, and Mercedes) with food by providing meals, cases of water and volunteers. TSA is preparing to ship 40 pallets of clean up kits and several pallets of mold sprayers and solution to the food bank in Pharr for distribution and 300 tarps in Aransas County. TSA of McAllen partnered with Catholic Charities providing clothing and other relief items to those affected. TSA has positioned a laundry unit at the Baptist Church in Weslaco for client usage.

Southern Baptist Texas Convention (SBTC): SBTC has staged at the First Baptist Church in McAllen, Hidalgo County, with four IMT Members, four assessors, five laundry members, one Chaplain, six Feeding team members and a Cleanup/Recovery Unit with six members. Forty-five mud-out requests have been received, 12 have been assessed and ready to work and seven homes were completed.

Texas Baptist Men Disaster Relief (TBM): TMB currently has an Incident Management Team (IMT) with the TBM command bus located in Weslaco, with two shower/laundry units, one box unit, assessors, Chaplains and three Flood Recovery units.

FINAL COMMENTS: The State of Texas State Operations Center (SOC) returned to Level IV (Normal Operations) at 6:00 PM on June 25, 2018. TDEM continues to monitor the situation and will provide additional situation reports as needed.

The four levels of SOC activation are:

Level I (Emergency Conditions)
Level II (Escalated Response Conditions)
Level III (Increased Readiness Conditions)
Level IV (Normal Conditions)
