

## Texas Crime Information Center (TCIC) Control Room and Audit

#### **Record Validation**

Validation is a very important procedure for locating inaccurate or invalid TCIC/NCIC records or for locating additional information that has become available since the records initial entry. New or corrected information can be obtained by reviewing the original warrant or case report which includes all supplemental attachments pertaining to said record, contacting the victim or complainant; by reaching out the courts, including prosecutors and reviewing jail and arrest files; or by speaking to investigators and detectives. You can also run a query to compare the record to all available information in TCIC during a validation. This has the great potential for providing your agency with new and updated information to include in an entry or to indicate that a person (wanted, missing or a party of a protection order) is deceased or incarcerated, so that your agency may take appropriate action on records that may no longer need to be in the TCIC/NCIC database. Driver license returns will also provide information on those persons who have recently renewed or obtained a DL or ID card.

By signing and returning the validation certificate each month, agencies are certifying the following:

- 1. The records contained on the validation listing have been reviewed by the originating agencies;
- 2. The records which are no longer current have been removed from the NCIC active database and all records remaining in the System are valid and active;
- 3. Records contain all available information; and
- 4. The information contained in each of the records is accurate.

Please note that during the pre-audit process, auditors will inquire into the vehicle registration, driver license and CCH databases to verify that all available information is included in each record. Upon arrival at your audit, they will also compare information included on an original warrant or in a case report (including supplemental attachments) to make sure all the information contained in the record matches the warrant or report.

### **Crime Information Bureau**

#### **TLETS MIGRATION TO OPEN FOX MESSENGER**

The Crime Information Bureau (CIB) will be challenged this year with the task of completing the migration of TLETS terminals. Over 10,000 Omnixx Force terminals will be converted to OpenFox Messenger. This migration will also include changes to Omnixx Console and Trainer. 2018 will also include ORI validation for the State of Texas and the testing of our TxGang Online Audit. The TCIC/TLETS training staff will end the year by updating our training manuals to reflect changes. We look forward to the challenges ahead in 2018 and for another opportunity to serve the state of Texas.

Statewide OpenFox Messenger Migration began 01/22/2018 and is scheduled to be completed on 07/06/2018. CIB is tasked with converting over 10,000 terminals across the state. We chose to schedule conversions by region to ensure that our internal resources would be available to assist our agencies through the transition. Our training and control room staff are working with agencies to coordinate resources to ensure a smooth transition to OpenFox Messenger. Our TLETS Program Administrators and Programmers continue to trouble shoot and work with our vendor to ensure issues found are resolved in a timely manner.

Once all terminals have been converted to OpenFox, Configurator 7.2 and nexTEST will replace Omnixx Console and Trainer. We will need to work with our vendor to configure and test this new component. Our training and TLETS staff will transition to developing and learning these new components so that we can train internal and external users. By December 2018 our Training staff will begin updating training materials to reflect OpenFox Messenger. We will need to update all components of our trainings and will return back to training in 2019.

2018 will mark a busy year for CIB. We will continue to convert terminals across the State to OpenFox Messenger. Our staff will begin to develop Configurator and nexTEST for release later this year. As well as update our training material and get ready to get back out there and train in 2019. Auditors will implement a new TxGang audit and continue to develop our current and new processes as needs arise. All these tasks will prepare us for the unforeseen challenges of 2019.

#### **NCIC/NIets ORI VALIDATION**

Every two years, states are required by NCIC and NIets to validate their agencies Originating Agency Identifiers (ORIs). Biennial ORI Validation is due at the end of this year. The TCIC Control Room will utilize the online audit process to provide instructions to our agencies to complete the validation within OpenFox Messenger. Once your notice is received, we ask that you please validate and/or update your agency's information utilizing the message key UORI.

#### **TXGANG AUDIT**

Our TCIC/TLETS Audit team will begin beta testing a new TxGang Online Audit with local agencies this summer. This will provide an opportunity for staff to become familiar with the process. As well as identify areas that may need to be corrected or adjusted within the TxGang audit process. The Audit team will begin to rollout the TxGang Audit statewide January 2019.

## Access and Dissemination Bureau (ADB)

#### Secure Site Account Users & Supervisors

The Secure Site allows criminal justice and non-criminal justice agencies access to criminal history record information for an authorized purpose. We currently have over 20,000 accounts and this number is growing daily. All account supervisors must ensure that all approved users are assigned to a supervisor. All supervisors must keep their account active and have signed their entity agreements. Users will be unable to perform criminal history searches if they are not being supervised or if their supervisor's account becomes inactive or disabled. This includes accessing the FACT Clearinghouse (fingerprints) to view records. Instructions are available on the website.

#### Audit Unit - CJIS

In January 2018, the Audit & Training Unit initiated the Full Electronic Audits. The audits provide efficiency in meeting the FBI requirements to triennially audit agencies receiving restricted state and FBI data. This audit format allows auditors to communicate with agencies in greater quantities. The onsite statewide audits will alternate with electronic audits in the future.

#### **Training Unit**

The Rap Back program was initiated on January 15<sup>th</sup> 2018, which required changes in the Secure Site training module for the Clearinghouse. It is imperative that all data users with access to the Clearinghouse take the training to maintain access.

CJIS Security Awareness Training is also mandatory for all agencies with access to the Secure Site Clearinghouse. If training is not completed, agencies will not be compliant with the FBI.

The Audit & Training Unit does offer training. The training consists of the usage of the TXDPS Secure Site and the CJIS Security Policy requirements.

#### FBI Civil Rap Back Program

On January 15, 2018, the Federal Bureau of Investigation (FBI) Civil Rap Back Program was implemented through the FACT Clearinghouse. The Department of Public Safety (DPS) now provides updated national criminal history record information along with Rap Back notifications on eligible active subscriptions that have been established in the FACT Clearinghouse. The following are some examples of what you can expect:

- Additional FBI Rap Back Worklists.
- Automatic Subscriptions to FBI Rap Back for new applicants printed on or after 01/15/2018.
- Validation of Subscriptions every 4 years, including Texas Only Subscriptions.
- Notification of any new arrests, dispositions, Sex Offender Registry activity, updates (expungements/ partial expungements), and death notifications, that occur within and outside of the State of Texas.
- No additional fees to participate in the FBI Civil Rap Back Program.

A criminal justice agency may submit applicant hard cards to the DPS for processing and use the FACT Clearinghouse to receive their Texas and FBI criminal history responses. If an agency chooses to submit applicant hard cards for fingerprint based background checks, the applicants must sign the Authorized Language Form and the forms must be retained by the submitting agency. A signed Authorized Language Form is also required to participate in the FBI Civil Rap Back Program.

#### 2018 Criminal Justice Information System (CJIS) Conference

#### New CJIS Field Support Supervisor

Crime Records Service would like to introduce John Morse as your new CJIS Field Support Supervisor. John began his career with the Department of Public Safety in 2000 as a Fingerprint Technician. He promoted to a CJIS Field Support Auditor in 2005. As a Field Support Auditor, he has worked with Criminal Justice Agencies across the state providing training and assistance in reporting to the criminal history database. In January 2018, John was promoted to the CJIS Field Support Supervisor.

#### CJIS Field Support Unit Region Coverage

With the promotion of John to the supervisor position and Rickey Harrison accepting another position within Crime Records Service, we are currently in the hiring process for 3 field auditor positions. In an effort to maintain coverage for our agencies, Region 4, Region 8 and Region 9 will temporarily be assisted by a field auditor from a different region. Once we complete the hiring and training of new field auditors, we will evaluate where to place them while maintaining statewide coverage.

#### Subscribing to the listserv

The CHRIP Bureau has a listserv to inform all of our reporting agencies of updates, changes and any notifications about what is happening with the CJIS and JJIS Reporting. All Offense Code updates and CJIS Conference Information are sent to the listserv.

If you would like to subscribe to the listserv, please follow these steps:

- 1) Send an email to LISTSERV@LISTSERV.DPS.TEXAS.GOV. Make sure that:
  - The subject line is left blank.
  - The message body is clear/blank (including signatures).
  - Type: SUBSCRIBE CJISJJIS First Name Last Name, in the message body.
- 2) Once you have completed that, you will receive an email stating that "You are now subscribed to the CJISJJIS list."

#### CJIS and JJIS Completeness Percentages

We are 3 months into 2018 and we wanted to remind you that the granting agencies will be looking at the 2012 through 2016 reporting years for the 90% Completeness Percentages. It is recommended that someone in each department for your county run a County Combined Completeness Report on a regular basis to track how your county is doing. If you are currently below 90% completeness in either Adult or Juvenile for the 5 year average then please contact your CJIS Field Support Auditor for information and assistance.

#### **Reporting Reminders**

Juvenile Referral Reporting Agencies- The most common mistake made on the CR-43J/CR-44J is dates.

#### There are three required dates in the Referral Section on the CR-43J and CR-44J reporting forms:

- Date of Fingerprinting (DOA)
- Date of Birth (DOB)
- Referral Date (ADA)

Please be sure to complete all of the required fields to ensure that the referral is entered into CCH in a timely manner.

#### CJIS SECURITY OFFICE

#### Online CJIS Security Technical Audit Process:

#### What is it?

An online process for agencies to complete the CJIS Security Technical Audit in a timely manner and reduce onsite visit time. The online audit includes reviews with the agency's technical auditor before the actual onsite visit is scheduled.

#### Who is affected by this?

The online audit affects those agencies requiring a triennial audit under the FBI CJIS Security Policy in section **5.11.2 Audits by the CSA.** If unsure, contact your CJIS Security Technical Auditor or the CJIS Security Committee to check if the agency is scheduled for this cycle.

#### Why is this being changed?

To streamline the overall process for the agencies and the time it takes conducting an on-site audit.

Allowing the agency to identify non-compliant issues and the ability to resolve them before the on-site visit, limits the interruption of normal duties experienced by the agencies.

The online process empowers the agency by allowing the Agency Coordinator the ability to add other personnel (such as the LASO, IT, etc.) to the online questionnaire process so they may assist the agency answering questions. This will aid in eliminating wait times and scheduling conflicts for responses from those individuals or sections.

#### How is it done?

The agency will be contacted by a technical auditor who will explain the process. Log in credentials will be verified, the audit assigned & an email generated providing the link plus other useful information. The agency will still receive an email from the auditor confirming the on-site visit, along with links to our website.

The agency inputs responses to the audit questions and submits back to their auditor for review. The auditor will review then determine if agency is compliant or not compliant; notes will be added if needed and submitted back to the agency for any updates. The entire process is available for review and monitor throughout by both the agency and the auditor. Once responses have been received the auditor will schedule a site visit for any follow up or questions remaining.

Once completed, the agency will have access to all completed audits, notes, and pending actions through this portal for reference and review as needed at any time.

## Electronic Arrest Reporting (EAR)/Livescan

#### Livescan DOs and DON'Ts:

When using a livescan to submit arrest data to Texas DPS it is important to remember the following dos and don'ts.

#### D<sub>0</sub>s

- Do check all return messages.
- **Do** review reject messages, correct transaction, and resubmit.
- **Do** use current version of offense codes.
- Do transmit adult class C offenses.
- Do use corresponding ADN for class C (233) and federal (234) offenses.
- **Do** submit a new set of fingerprints for each arrest.

#### DON'Ts

- Do not transmit out of state probation and paroles via livescan.
- Do not resubmit any transactions; verify with DPS first (Call 512-424-5248). For corrections or added charges, use the CJIS site: https://cch.dps.texas.gov/CJISAuth/login/CJIS or fax to 512-424-2476.
- Do not use offense code 99999999.
- Do not submit Juvenile class C offenses.
- **Do not** transmit a juvenile offense if the referral date is past 10 days.
- **Do not** populate an arrest record with identification database on a name search from a DL search.

## Incident Based Reporting Bureau (IBRB)

The Crime Records Service is excited to announce the merger of the Texas Data Exchange (TDEx) and Uniform Crime Reporting (UCR) programs under the umbrella of the new Incident Based Reporting Bureau (IBRB)! Due to the similarities in the incident data that is contributed through both TDEx and UCR programs, the bureau will be able to identify opportunities to streamline information sharing to agencies that contribute to both programs. In addition, IBRB field representatives will be able to educate agencies that are either new or already contributing data to either program on the benefits, overlap, and unique data sets between the two. We are looking forward to a great year with many changes, and will be sure to communicate new happenings for the bureau with agencies over the coming months.

#### Texas Data Exchange (TDEx)

TDEx Audit Process:

Every three years, criminal justice agencies accessing CJIS systems and the National Data Exchange (N-DEx) are required to undergo an audit to ensure compliance with the FBI's CJIS Security Policy (CSP) and N-DEx program requirements. In an effort to ensure compliance with CSP and N-DEx, the TDEx program will be implementing the TDEx audit process for the purpose of evaluating compliance with policy and program requirements associated with access to, use, and dissemination of information derived from CJIS systems.

Over the next several months, TDEx will be identifying and contacting potential pilot criminal justice agencies across Texas to test the proposed audit process which will require response to a preliminary questionnaire, and participation in a pre-audit, interview and assessment, and a post-audit follow up with the Department's TDEx auditor. Upon completion of the pilot, TDEx will update and formalize the audit process and begin outreach to inform all contributing agencies of next steps, training and important dates. #### **Uniform Crime Reporting (UCR)**

Crime in Texas Online:

The *Crime in Texas* (CIT) Online Portal was released in January 2018, and was developed to provide a platform for the public to access online and on demand statistical and analytical information about crime reported in the state. The Portal allows users to create unique queries utilizing specific data points associated with selected contributing entities, resulting in a more intuitive way to gather statistical data that is tailored to the needs of the requestor, without the need to make a manual request to the UCR program office.

Please keep in mind that crime data available through the CIT Online Portal is dynamic and reflects data that may have been reported to the program after the publication date for the CIT publication, which is a snapshot in time. Because of the possibility for continuous updates to the data available in the portal, users must be aware that statistics from the Portal may not align with statistics published in the CIT publication for the same given time period.

We value all feedback as our goal is to make the public portal as easy to use as possible, and to provide the public with a system allowing them to conduct research, trend analysis, comparisons and statistical review for contributing UCR agencies across the state. #### **NIBRS** Regional Workshops

House Bill 11 (HB11) of the 84th Regular Session introduced the requirement for Texas to begin its transition from a primarily Summary Reporting (SRS) state to a National Incident Based (NIBRS) state, by setting a goal for transition to NIBRS by September 2019. While the number of NIBRS contributors within the state is increasing daily, the majority are still SRS reporting agencies.

The Department of Public Safety will be hosting a series of information/training sessions around the state during the month of May 2018 to assist agencies in making the transition from SRS to NIBRS, and to meet the state goal of September 2019. This workshop will cover the following topics:

- TTIC (Texas Transnational Intelligence Center) Overview
- UoF (Use of Force) Overview
- Texas UCR Repository Portal Overview

## **SEX OFFENDER REGISTRATION (SOR)**

#### Sex Offender Registration Year End Review

Another year has passed and we would like to take this opportunity to re-cap some of the highlights of 2017 involving sex offender registration.

#### **SOR Conference**

The 2017 State of Texas Sex Offender Registration Conference gave us the opportunity to inform attendees of the recent legislative changes to the registration program as well as provide insight into various aspects of agencies or activities involved with the registration, compliance or monitoring of registered sex offenders. Highlights of legislative changes include:

- Residency Restrictions: Institutions of Higher Education (HB 355)
- Changes to Civil Commitment Requirements (SB 1576)
- Addition of Continuous Trafficking and Bestiality to the list of offenses requiring registration (HB 29 and SB 1232)
- Registrant Notice Upon Entry onto School Premises (SB 1553)
- Limitations on Registered Sex Offenders in General Law-Municipalities (HB 1111)

Detailed information regarding these bills and the changes made are summarized in a document called "Legislative Change Summary – 2017 SOR" located within the Notices, Forms, Resources section in the Secure Sex Offender Registration web site.

Conference organizers are currently working on securing a location for our next conference projected in 2019. Updates regarding our next conference will be made available as they develop. We hope that you have the opportunity to attend and look forward to seeing you there!

#### **Backlog Reduction Initiative**

2017 was a year for which the Bureau embarked on a backlog reduction initiative related to errors or rejected initial registration record reporting. Field representatives worked diligently to resolve errors and made movements to ensure that contact was made with contributors on initial registrations that were rejected. The second phase of this project requires on-site visits with contributors; therefore, field representatives will be taking errors to local agencies in an attempt to correct these submissions and update the registry.

The Bureau would like to stress the importance of capturing a verifiable set of fingerprints in addition to collecting and reporting complete offense information when completing the initial registration. These two items have been identified as the most common reason why a registration record cannot be created on a person.

#### Field Representatives: Update on Vacancies, Region Changes and Field Training

The field representative unit of the Bureau has had some personnel changes during the year of 2017. The majority of vacancies have been filled and new hires have started to travel to conduct requested trainings, to conduct field visits, as well as, correct errors with agencies.


Changes have also occurred regarding the geographic regions that each field representative represents. The state is now divided into 6 Regions. Region 1 currently has a field rep vacancy for which we hope to fill in the near future. Field representatives from other areas will be traveling out to Region 1 to help support this area. The updated Regional Map is located on page 9.

#### **Updated Web Sites**

Both the Secure and Public Sex Offender Registration web sites went through enhancements in the third quarter of 2017. Secure Site enhancements allowed local users to have more accessibility to update or amend information contained in the record. Users can now make edits to information submitted by their agency and entry has been expanded to allow contributors to enter initial registration information when the person is identified in the registry. Entries of verification and change of status events have been streamlined to lessen the number of screens a user needs to navigate through, lessening the time it takes to report these specific events.

Help file and resource information have also been expanded to assist users with the new site. This information is available within the Notices, Forms, Resources section in the Secure Sex Offender Registration web site. The Bureau is also endeavoring in modifying training curriculum to include both Registration and Web Site training. Agencies will be able to receive information on how to register offenders and learn how to access and navigate the web site at the same time. Stay tuned for developments on this project.
