This surety bond will be used as outlined in Texas Commercial Driver License Third Party Skills Testing Memorandum of Understanding and as provided by 37 Texas Administrative Code Chapter 16 to promptly pay all reasonable expenses for re-testing drivers in the event that the Principal or one or more of the its examiners are involved in fraudulent activities related to skills testing. Payment by the surety shall be made upon presentation of evidence from the Department that reasonably demonstrates the requirement for retesting
