Skip the Trip

Renew online!

Eligible Texas residents may renew their driver license (DL) or identification card (ID) online at the DPS Driver License Division and Texas.gov renewal web page:

www.texas.gov/texas-by-texas/

Step 1 - You are eligible to renew online if:

- You last renewed your driver license in person at a Texas driver license office
- You have a Class C, M or CM driver license or a Class A, AM, B, BM, C or CM commercial driver license without a hazardous material endorsement. You cannot renew a commercial driver license with a hazardous materials endorsement online
- Your driver license either expires in less than two years, or has been expired for less than two years
- You are at least 30 days from turning 18 years of age and your driver license is a provisional license
- You are younger than 79 years of age
- Your vision and your physical and mental conditions have not changed in a way that affects your ability to drive safely since your last renewal
- You hold a commercial driver license and your medical certificate on file is valid and not expired
- Your license is valid (not suspended or revoked) and you do not have any unpaid tickets
- You are a U.S. citizen
- Your Social Security Number (SSN) is already on file

Step 2 - To renew online, you must have the following:

- Your most recently issued Texas driver license or identification card (the one you are renewing) and the audit number from the card
- A printer to print your temporary license and payment receipt or an email address to receive your temporary license and payment receipt
- A valid credit card (MasterCard, Visa, Discover, or American Express)
- The last four digits of your SSN

Phishing Alert!

Beware of look-alike websites that are not the official Texas Department of Public Safety Driver License Division website (<https://www.texas.gov/driver-services/>) or the official State of Texas website (Texas.gov)!

To prevent fraudulent use of your personal information and avoid paying unnecessary fees, only renew your driver license or identification card online at the official government agency website:




When you type our website address online, enter it in the address bar at the top of your browser (Internet Explorer, Mozilla Firefox, Google Chrome, Safari, Opera, etc.) instead of your search engine bar (Google, Bing, Yahoo, Ask, AOL, etc.).

If you enter it in your search engine bar, the first few websites listed – usually with a highlighted background – are advertisements by private organizations that may be fraudulent.
