The Texas Department of Public Safety is responsible for enforcement, licensing and other regulatory duties under the various statutes. These statutes regulate the Compassionate Use Program (CUP), the Compassionate Use Registry of Texas (CURT), private security industries, vehicle inspection programs, metals recycling programs, ignition interlock devices, and handgun licensing in Texas. Department policy requires new employees relinquish, at the time of hire, any professional license or certificate held that is listed below and issued under any of the above referenced programs. This policy further requires that they not seek any such license or certificate while employed at the Department. Department policy also prohibits employees from engaging in secondary employment in these industries. The above does not include a prohibition on holding a personal license to carry a handgun.
