INSTRUCTIONS

1. Show in this report all persons 18 years of age and over taken into custody during the month for committing an offense of the indicated types within the local jurisdiction. (Include those released without having been formally charged.)
2. The offenses are taken from the uniform classification of offenses and cover all the Part I and Part II offenses **except traffic**. In compiling the data, follow definitions of offense in Uniform Crime Reporting Handbook.
3. Enter opposite each offense the number of persons taken into custody listing them according to age and sex of the persons arrested, and according to race and ethnic origin without regard to sex.
4. **Juveniles.** Arrests of persons under 18 years of age are tallied on the Age, Sex, Race and Ethnic Origin of Persons Arrested, Under 18 Years of Age reporting form (UCR-11).

5. Racial Designations.

- **White** — a person having origins in any of the original peoples of Europe, North Africa, or the Middle East.
- **Black or African American** — a person having origins in any of the black racial groups of Africa.
- **American Indian or Alaskan Native** — a person having origins in any of the original peoples of North America and who maintains cultural identification through tribal affiliation or community recognition.
- **Asian** — a person having origins in any of the original peoples of the Far East, Southeast Asia, the Indian subcontinent including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippines Islands, Thailand and Vietnam.
- **Native Hawaiian or Pacific Islander** — a person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands, e.g., individuals who are Carolinian, Fijian, Kosraean, Melanesian, Micronesian, Northern Mariana Islander, Palauan, Papua New Guinean, Ponapean (Pohnpelan), Polynesian, Solomon Islander, Tahitian, Tarawa Island, Tokelauan, Tongan, Trukese (Chuukese) and Yapese.

NOTE: The term “Native Hawaiian” does not include individuals who are native to the State of Hawaii simply by virtue of being born there.

6. Ethnic Origin

Ethnic designations are:

- **Hispanic or Latino** — all persons of Mexican, Puerto Rican, Cuban, Central or South American, or other Spanish culture or origin, regardless of race.
- **Non-Hispanic or Non-Latino.**

Agencies use only these ethnic designations — regardless of any additional ethnic categories they may use in their agency records management systems.
