LTC applicants may be eligible for a discount and/or certain exemption(s) based on what condition they apply under.

Application Conditions

<u>Standard Condition</u> Individuals who do not meet the requirements for any discount.	OR = \$140	RE = \$70
<u>Active Judicial Officer</u> Individuals who are serving as judges or justices of the supreme court, the court of criminal appeals, a court of appeals, a district court, a criminal district court, a constitutional county court, a statutory county court, a justice court, or a municipal court; or a federal judge who is resident of Texas; or persons appointed and serving as associate judges.	OR = \$25	RE = \$25
<u>Retired Judicial Officer</u> Individuals who were serving as judges or justices of the supreme court, the court of criminal appeals, a court of appeals, a district court, a criminal district court, a constitutional county court, a statutory county court, a justice court, or a municipal court; or a federal judge who is resident of Texas; or persons appointed and serving as associate judges.	OR = \$25	RE = \$25
<u>Active Military</u> Individuals currently serving in the military OR who were honorably discharged within the last 365 days.	OR = \$0	RE = \$0
<u>Active TX Peace Officer/Correctional Officer (TDCJ)/Supervision or Juvenile Probation Officer/Active Texas Military Member</u> Licensed peace officers under Chapter 1701, Occupations Code, and are employed as a peace officer by a Texas law enforcement agency; or Texas Department of Criminal Justice (TDCJ) Correctional Officer; or a Texas Supervision or Juvenile Probation officer; or an Active Texas Military Member.	OR = \$25	RE = \$25
<u>Honorably Retired Texas Peace Officer</u> Individuals who were licensed as peace officers under Chapter 1701, Occupations Code, and who had been employed full-time or a reserve peace officer by a Texas law enforcement agency.	OR = \$25	RE = \$25
<u>Retired Federal Officer</u> Individuals who are retired Officers of the United States who were eligible to carry a firearm in the discharge of the officer's official duties.	OR = \$25	RE = \$25
<u>Senior Citizen</u> Individuals who are at least 60 years of age at the time of application.	OR = \$70	RE = \$35
<u>Indigent</u> Individuals who fall below the poverty threshold as set forth by the Federal Poverty Guidelines.	OR = \$70	RE = \$35
<u>Felony Prosecuting Attorney</u> Individuals who are elected attorneys representing the state in the prosecution of felony cases who meet the requirements.	OR = \$0	RE = \$0
<u>Veteran (Honorably Discharged)</u> Individuals honorably discharged from military service.	OR = \$25	RE = \$25
<u>Other / Assistant Prosecutor</u> Individuals who are prosecuting attorneys or assistant prosecuting attorneys	OR = \$140	RE = \$70
<u>Instructor Certification</u> Certified Instructors are individuals trained and certified by Texas Department of Public Safety to instruct License To Carry a Handgun training courses to the public.	OR = \$100	RE = \$100
