"Total Convictions in Texas" includes all convictions reported to the state criminal history repository for the offense during the calendar year for individuals age 21 or over. CCH Conviction counts based on CDN codes 310, 311, 326, 331, 332, 334, 397, and 398.

"Convictions of Handgun Lic Holders" includes any conviction reported to the Handgun Licensing Program for which the convicted individual held a license to carry a handgun at the time the offense was committed.

"Handgun Lic Holder Percentage of Total Convictions" is a percentage derived from the ratio of CHL holder convictions to total convictions for the offense.
