## METALS GLOSSARY

- 1. Statutory Agent The person or entity to whom any legal notice may be delivered at each location.
- Required Ownership Documents In order to conduct business in the State of Texas, business
  owners must file the proper documentation with the State and/or County. As part of your
  Metals Registration Application, please select your business type from the list below and be
  prepared to upload or fax the appropriate documentation.
  - a) Sole proprietorship: If the business is conducted under an assumed name (a name other than the surname of the individual), then an <u>assumed name certificate</u> is necessary. If the owner conducts business under his own surname, then a letter to that affect must be submitted instead of the assumed name certificate.
  - b) **General partnership**: If the business of the partnership is conducted under an assumed name (a name that does not include the surname of all of the partners), then an <u>assumed name certificate</u>. If the partners conduct business under their own surnames, then a letter to that affect must be submitted instead of the assumed name certificate.
  - c) Corporations, Limited Liability Companies, Limited Partnerships: A copy of the <u>certificate</u> <u>of formation</u> filed with the Texas Secretary of State. (If the Corporation is filed outside the State of Texas, the Corporation must file as a Foreign Corporation with the Texas Secretary of State. Foreign Corporations must then submit a copy of the <u>certificate of filing</u> for this application.)
  - d) **Limited Liability Partnership**: A copy of the <u>registration form</u> filed with the Texas Secretary of State.

- 3. Business Owner(s) A proprietor, partner, member or individual listed in the ownership documents
- 4. Location A building or structure <u>at which the applicant proposes to conduct business</u> for which a certificate of occupancy can be issued. **(combined language from 36.1(f) and 36.3 (d))**
- 5. City/County Permits Any license/permit issued by a county, municipality or political subdivision to a business to allow the business to act as a metal recycling entity.
- 6. Issuing Authority Any county, municipality or political subdivision that issues permits to businesses allowing the business to act as a metal recycling entity.
- 7. Metal Recycling Entity A business that is operated from a fixed location and predominantly engaged in:

- a. Performing the manufacturing process by which scrap, used, or obsolete ferrous or nonferrous metal is converted into raw material products consisting of prepared grades and having an existing or potential economic value, by a method that in part requires the use of powered tools and equipment, including processes that involve processing, sorting, cutting, classifying, cleaning, baling, wrapping, shredding, shearing, or changing the physical form of that metal;
- b. The use of raw material products described under Paragraph (A) in the manufacture of producer or consumer goods; or
- c. Purchasing or otherwise acquiring scrap, used, or obsolete ferrous or nonferrous metals for the eventual use of the metal for the purposes described by Paragraph (A) or (B).
- 8. Explosives or explosive components TEXAS CRIMINAL AND TRAFFIC LAW MANUAL PENAL CODE TITLE 10. OFFENSES AGAINST PUBLIC HEALTH, SAFETY, AND MORALS Chapter 46. Weapons § 46.01. Definitions.
  - (2) "Explosive weapon" means any explosive or incendiary bomb, grenade, rocket, or mine, that is designed, made, or adapted for the purpose of inflicting serious bodily injury, death, or substantial property damage, or for the principal purpose of causing such a loud report as to cause undue public alarm or terror, and includes a device designed, made, or adapted for delivery or shooting an explosive weapon.
- 9. Rejected Load 90 day Report a report that contains all MREs for the last 90 days that reported rejecting a load. Reported by county. Rejecting a Load is contained in "add a transaction".
- 10. Theft Notification current messages related to theft of regulated materials and metals from across the state. Go to Message Center to review theft notifications.
