Changes & Accomplishments: the Texas Data Exchange (TDEx)

The Texas Data Exchange (TDEx) Bureau saw some changes and accomplishments in 2016.

At the end of 2015, the TDEx Bureau was without a contract. This meant that there was no data being collected and/or pushed to the National Data Exchange (N-DEx). That changed, however, in the first quarter of 2016. A new contract was put in place in March of 2016 and the Department began the task of bringing agencies back online as contributors of data. This required the installation of new adapters at the contributing agencies and as a result, progress was slow.



In an effort to get data flowing to N-DEx at a faster

rate, the Bureau entered into a secondary contract. This secondary contract would allow for all previously contributing agencies to be brought back online with the existing adapters as the agencies awaited the deployment of new adapters. This allowed for more data to be pushed to N-DEx.

As of October 2016, the state of Texas has shared 112,157,635 records with N-DEx. The state of Texas is the biggest contributor of data in the country. Texas records make up about 35% of the total records in N-DEx.

The goal of the Bureau is to have as many contributing agencies as possible. With that in mind, the Bureau is pursuing a new strategy. Instead of utilizing adapters installed at the contributing agencies, the Department will be working with the RMS/JMS vendors of the local agencies to push RMS/JMS data directly to the Department. The Department is currently seeking information from vendors with regards to establishing a data broker, that would collect data and push it to N-DEx and any other database that the Department wishes to have populated, such as the NIBRS repository.

The importance of data sharing was realized by the Department when the FBI presented a DPS Analyst with an award for sharing the Success Story of the Year. The Department was in the process of adding an absconded pedophile to its Top 10 Most Wanted list. The Analyst searched various databases for information on the absconder. It was not until the Analyst searched N-DEx that information on the absconder was located. The Analyst found a Missing Person report out of New York that listed the absconder as the complainant. He had reported his sister missing. In that report, the Analyst found the absconder's California address. The absconder was arrested by local law enforcement, acting as federal marshals, without incident. In short, a Texas fugitive was apprehended in California based on a New York record submitted to N-DEx.

Access & Dissemination

Moving to FACT Clearinghouse

The Department of Public Safety (DPS) created the Fingerprint-based Applicant Clearinghouse of Texas (FACT) to provide state and federal fingerprint-based criminal history results in one consolidated electronic format for authorized agencies. Persons fingerprinted with an agency's ORI number are automatically subscribed to the agency's FACT Clearinghouse account. This subscription service ensures that an agency will receive email notifications for new arrests or court dispositions (Rap Back) that may occur on the subscribed person's criminal history record.

With this in mind, The FACT Clearinghouse is the only method DPS will offer to deliver fingerprint results. Effective January 1, 2016, DPS discontinued all other avenues to receive applicant fingerprint-based criminal history checks results.

Most Criminal Justice Agencies have already moved over to the FACT Clearinghouse for their responses and DPS wants to ensure that the shift to the FACT Clearinghouse is a smooth transition for all criminal justice agencies. The Rap Back & Secure Site Training Unit at DPS is offering trainings to Criminal Justice Agencies to discuss the current FACT Clearinghouse, Secure Site, The Texas and upcoming FBI Rap Back programs, the Audit processes, and much more pertaining to the DPS Secure Site.

CRIMINAL JUSTICE INFORMATION SYSTEM (CJIS)

Reporting Requirements

The Department of Public Safety (DPS) Criminal History Reporting Information Processing (CHRIP) Bureau has begun a monthly report that tracks court disposition reporting time frames. As per the Code of Criminal Procedure (CCP) Chapter 60.08(d), Prosecutors and Courts shall report disposition information to DPS by the 30th day after they have received the information.

Art. 60.08. REPORTING. (a) The Department of Public Safety and the Texas Department of Criminal Justice shall, by rule, develop reporting procedures that:

(d) Except as otherwise required by applicable state laws or regulations, information or data required by this chapter to be reported to the Texas Department of Criminal Justice or the Department of Public Safety shall be reported promptly but not later than the 30th day after the date on which the information or data is received by the agency responsible for reporting it except in the case of an arrest. An offender's arrest shall be reported to the Department of Public Safety not later than the seventh day after the date of the arrest.

We will be sending a report via encrypted email or through USPS each month to the County Judge of each county. This report can be utilized by your disposition reporting agencies to help in identifying possible reasons or issues that are causing the dispositions to be reported after the 30 day time frame. Completeness Reports

Soon it will be a new year and we want to remind you that the 90% completeness requirements will be looking at the 2011 through 2015 reporting years beginning in January 2017. It is recommended that someone in your county run a County Combined Completeness Report on a regular basis to track how your county is currently doing. If you are currently below 90% Completeness in either Adult or Juvenile for 5 year average then you should contact your CJIS Field Support Auditor for information and assistance.

Reporting Reminders

Juvenile Referral Reporting Agencies – There are three required dates in the Referral Section of the CR-43J and CR-44J reporting forms, the Date of Fingerprinting (DOA), the Date of Birth (DOB), and the Referral Date (ADA). Please be sure to complete all of the required fields to ensure that the referral is entered into CCH in a timely manner.

CRIMINAL JUSTICE INFORMATION SYSTEM (CJIS) Security Office

Welcome to the TX CJIS Security Office

Under the FBI's Criminal Justice Information Service (CJIS) Security Policy provisions, the Department of Public Safety (DPS) serves as the CJIS Systems Agency for the State of Texas. The policy areas focus upon the data and services that the FBI CJIS Division exchanges and provides to the criminal justice community and its partners. Our experienced and professional staff is responsible for auditing local agencies to ensure compliance with the technical aspects of the FBI CJIS Division's policies and regulations.

The CJIS Technical Security Auditor Team is comprised of a diverse and experienced group of members here to assist and guide agencies in meeting the FBI CJIS Security Policy. Our focus as technical security auditors encompasses safeguarding of CJIS data across agencies within the State of Texas. The audit process includes interviewing personnel at user agencies and the inspection of computer and network equipment of each agency to ascertain compliance.

We are tasked with auditing each one of some 1300+ sites throughout the State of Texas, at least once during a three year cycle. Our team has traveled in excess of 78,889 miles performing on-site audits throughout the State of Texas during the 2016 Fiscal year.

Fingerprint Processing

Electronic Arrest Reporting (EAR)/Livescan DOs and DON'Ts

When using a livescan to submit arrest data to Texas DPS it is important to remember the following dos and don'ts: Dos-

- Do check all return messages.
- Do review reject messages, correct transaction, and resubmit.
- **Do** use current offense codes (version 15).
- **Do** transmit adult class C offenses.
- Do use corresponding ADN for class C (233) and federal (234) offenses.

DON'Ts-

- Do not transmit out of state probation and paroles via livescan.
- Do not resubmit any transactions; verify with DPS first (Call 512-424-5248). For corrections or added charges, use the CJIS site: <u>https://cch.txdps.state.tx.us</u> or fax to 512-424-2476.
- Do not use offense code 99999999.
- Do not submit Juvenile class C offenses.
- **Do not** populate an arrest record with identification database on a name search from a DL search.

SEX OFFENDER REGISTRATION (SOR)

Sex Offender Registration Validations

The migration of the sex offender registration records subject to validation and various supplemental reports to the TCIC web site is complete. Agencies have been receiving these records via the web site for a couple of months, however, there are still some agencies for which a TCIC web site account will need to be created in order to receive and validate records. Agencies that have records subject to validation but do not have access to the TCIC web site will be identified and contacted to set up an account. Paper validations and supplemental reports will be temporarily printed and mailed to the agency to allow for time for an account to be set up. Follow up will be conducted to ensure that an account is created.

Some agencies may have questions, and the type of question will determine which area within Crime Records can assist.

-If your agency has questions regarding what are Sex Offender Registration Validations or how to complete Sex Offender Registration Validations then please contact the Sex Offender Registration Bureau at txsor@dps.texas.gov or (512) 424-2800.

Validation is a requirement of the FBI. Since agencies have until the 25th of the following month that the validation report is generated to validate the records, immediate access to those records via the TCIC web site will help local agencies fulfill that obligation.

Support Operations Unit

The Support Operations Unit within the Sex Offender Registration Bureau provides consultative and technical program assistance, research, and analysis work in support of the Texas Sex Offender Registration Program. The unit oversees the Community Postcard Notification Program for sexual predators and high-risk offenders and also performs quality control of the Sex Offender Registration (SOR) database utilized by statewide law enforcement personnel to enter and update sex offender information.

Other programs Support Operations maintains or monitors are: Institutes of Higher Education, Occupational Licenses, Certified Sex Offender (CSO) flag export, TCIC/NCIC errors, technical upgrades and updates to the registration websites, social networking, agency and user account approval and removal, web services, Livescan, and many other peripheral functions.

UNIFORM CRIME REPORTING (UCR)

Changes to the Uniform Crime Reporting (UCR) System

The Department posted and awarded a contract for a new Uniform Crime Reporting (UCR) in June 2016. Since that time, the Department has been working with the selected vendor, Optimum Technology, on the requirements of this new system and implementation of a new user interface and data repository. This new system will be a significant change to what users are accustomed to seeing and will result in increased functionality.

The Department will target implementation of the new system by the second quarter of 2017 (no later than June 2017). The Department will be providing information as it becomes available and will be exploring multiple methods to get our agencies information on how to use the system.
