

**MEMORANDUM OF UNDERSTANDING
BETWEEN THE DEPARTMENT OF JUSTICE AND
THE TEXAS DEPARTMENT OF PUBLIC SAFETY**

Purpose, Objective, and Scope

1. This Memorandum of Understanding (“MOU”) is entered into by the Department of Justice (“DOJ” or “Department”) and the Texas Department of Public Safety (“DPS”) on behalf of the local sharing system, Texas Data Exchange (“TDEx”). The Department, through the Federal Bureau of Investigation, operates the Regional Data Exchange System, (“R-DEx”). The purpose of this MOU is to set forth policy and procedures for the sharing of law enforcement information by the parties and contributing agencies, including the ownership and use of shared information.
2. The objective of the collaborative peer relationship described in this MOU is to facilitate a program to share law enforcement information among federal, state, and local law enforcement partners. Through this relationship, the parties intend to capture the cumulative knowledge of regional law enforcement agencies at all levels in a systematic and ongoing manner to maximize the benefits of information gathering and analysis needed to respond to criminal threats, to support law enforcement activities, and to enhance public safety and force protection for the Nation's critical infrastructure in the region covered by this partnership.
3. This MOU will not affect any pre-existing, independent relationships or obligations between the parties or between the parties and any third parties.

Parties

4. The parties to this agreement are DOJ and the State of Texas, acting by and through DPS.
5. TDEx is a data repository containing information from law enforcement and criminal justice agencies across the entire state. Attachment A of this MOU contains a list of the agencies that will have access to R-DEx. DPS may approve additional TDEx contributing law enforcement agencies, provided that all such agencies agree to be bound by the terms of this MOU.
6. R-DEx is a data repository containing information from five contributing DOJ components: the Bureau of Alcohol, Tobacco, Firearms and Explosives; the Federal Bureau of Prisons; the Drug Enforcement Administration; the Federal Bureau of Investigation; and the United States Marshals Service. Agencies that will have access to R-DEx are local, state and federal law enforcement agencies that are authorized by state or federal law to employ peace officers. The Department may approve additional contributing components, which will be bound by the terms of this MOU.
7. The Department will designate a Special Agent in Charge, a representative from the United States Attorneys Office or another appropriate representative from a DOJ contributing

component to serve as a point of contact to address operational issues with the Director, Texas Department of Public Safety.

Authority

8. Authority for the Department to enter into this MOU includes: 28 U.S.C. 533 and 534.

9. Authority for DPS to enter into this MOU includes Texas Government Code Chapter 411, § 421.002.

The Department Access to and Use of TDEx Information

10. Department users will be provided access to TDEx in the same manner as users from TDEx agencies. DPS will provide training to Department users. This training will be provided to make users aware of what information can be accessed from TDEx via R-DEx, and will include a description of the information contained in the system, a typology of included investigative reports, third-party rules, de-confliction and coordination requirements, and other appropriate information. For the purposes of this MOU, all participating Department components will have the same access as TDEx agencies.

11. The Department will have initial access to TDEx through terminals located in DOJ offices. Eventually, DOJ access to TDEx will occur via Internet connections meeting CJIS Security Policy security requirements through R-DEx. The Department is responsible for providing its own secure Internet connectivity and maintenance.

12. Each TDEx contributing agency retains sole ownership of, sole responsibility for, and exclusive control of the information that it contributes to TDEx, and it may at will update, correct, or delete the information it contributes to TDEx.

13. Each TDEx contributing agency has the sole responsibility to ensure that information that it contributes to TDEx was not obtained and is not maintained in violation of any federal, state, or local law applicable to that agency. In addition, each contributing agency has the sole responsibility and accountability for ensuring compliance with all laws, regulations, policies, and procedures applicable to its entry and sharing of information into TDEx.

14. Each TDEx contributing agency has the duty, sole responsibility, and accountability to make reasonable efforts to ensure the accuracy upon entry, and continuing accuracy thereafter, of information that it contributes to TDEx. Should the Department receive a challenge to or reasonable question about the accuracy of information contributed to TDEx, the Department will notify the contributing agency and DPS in writing.

15. The Department may access and use TDEx information for official criminal justice purposes only. TDEx information cannot be accessed or used for any other purpose, including general licensing, employment, eligibility for federal or state benefits, or background

investigations. TDEx information will be shared with the Department under an express promise of confidentiality. The Department will protect such information from disclosure to the greatest extent possible consistent with the Freedom of Information Act, the Privacy Act of 1974, the Texas Public Information Act, and any other applicable public access law and applicable compulsory process. The Department will notify DPS immediately upon becoming aware of an information demand or a lawsuit brought in any court seeking access to information in TDEx, in either verbatim or derivative form.

16. TDEx information, including any analytical products derived therefrom, may not be used as a basis for action or disseminated outside DOJ for any purpose or in any other manner, unless the Department first obtains the express permission of the agency or agencies that contributed the information in question. Included within this prohibition is any specific inclusion of TDEx information in an official case file, and any use of TDEx information in the preparation of judicial process such as affidavits, warrants, or subpoenas. Department users of TDEx information may not print, copy or electronically retain TDEx information without obtaining the contributing agency's permission. When TDEx information is summarized or otherwise documented, the Department user shall indicate that the information was obtained from TDEx.

17. Notwithstanding the requirement in the preceding paragraph that TDEx information not be used as a basis for action or disseminated without first obtaining the permission of the contributing agency, in accordance with and to the extent permitted by applicable law, court process, or applicable guidelines, immediate dissemination of TDEx information without such permission may be made if the Department determines that:

- (a) there is an actual or potential threat of terrorism, immediate danger of death or serious physical injury to any person, or imminent harm to the national security; and
- (b) it is necessary to disseminate such information without delay to any appropriate recipient for the purpose of preventing or responding to such a threat, danger, or harm.

The TDEx contributing agency and DPS shall be immediately notified of any dissemination made under this exception.

18. Any requests for reports or information in TDEx from anyone other than a party to this MOU or a TDEx or DOJ contributing agency will be directed to the contributing agency.

TDEx Agency Access to and Use of R-DEx Information

19. The Department will permit TDEx users that have querying capability to access and use information in R-DEx. The Department will provide required training for TDEx users of R-DEx information. This training will be provided to make R-DEx users aware of what information can be accessed from R-DEx via TDEx, and will include a description of the information contained in the system, a typology of DOJ investigative reports, third-party rules, de-confliction and coordination requirements, and other appropriate information.

20. TDEx users will have access to R-DEx via an Internet connection meeting CJIS Security Policy requirements. Participating TDEx agencies are responsible for providing their own Internet connectivity and maintenance.

21. TDEX participating agency users with access to R-DEx shall be analysts, agents, investigators, detectives, or other criminal justice officials who are trained on the protocols for the appropriate use of inter-jurisdictional law enforcement information.

22. Each Department contributing component retains sole ownership of, sole responsibility for, and exclusive control over the information that it contributes to R-DEx, and may at will update, correct, or delete that information.

23. Each Department contributing component has the sole responsibility to ensure that information that it contributes to R-DEx was not obtained and is not maintained in violation of any applicable law. In addition, each Department contributing component has sole responsibility and accountability for ensuring compliance with all laws, regulations, policies, and procedures applicable to the posting of its information in R-DEx.

24. Each Department contributing component has the duty, sole responsibility, and accountability to make reasonable efforts to ensure the accuracy upon entry, and continuing accuracy thereafter, of information that it contributes to R-DEx. Should a TDEx agency receive a challenge to or reasonable question about the accuracy of information in R-DEx, the TDEx agency will notify the Department contributing component and DPS in writing.

25. TDEx agencies will access and use R-DEx information for official criminal justice purposes only. R-DEx information cannot be accessed or used for any other purpose, including general licensing, employment, eligibility for federal or state benefits, and background investigations. The Department retains control and ownership of the information that its components contribute to R-DEx. The Department components contribute and share information via R-DEx under an express agreement that confidentiality will be preserved. R-DEx information may not be disclosed in response to a request made under any state or local access law. Information in R-DEx may only be disclosed in accordance with applicable federal law, including the Freedom of Information Act and the Privacy Act. TDEx agencies will notify DPS and the Department contributing component immediately upon becoming aware of a lawsuit or a preceding information demand brought in any court seeking access to, or disclosure of Department information, in either verbatim or derivative form.

26. R-DEx information, including any analytical products derived therefrom, may not be used as a basis for action or disseminated for any other purpose or in any other manner outside the TDEx agency that accessed the information, unless that agency first obtains the express permission of the DOJ contributing component. Included within this prohibition is any specific inclusion of R-DEx information in an official investigative or case file, and any use of R-DEx information in the preparation of judicial process such as affidavits, warrants, or subpoenas. TDEx users of R-DEx information may not print, copy, or electronically retain R-DEx information without obtaining the Department contributing component's permission.

When R-DEx information is summarized or otherwise documented, the TDEx user shall indicate that the information was obtained from R-DEx.

27. Notwithstanding the requirement in the preceding paragraph that R-DEx information not be used as a basis for action or disseminated without first obtaining the permission of the Department contributing component, in accordance with and to the extent permitted by applicable law, court process, or applicable guidelines, immediate dissemination of R-DEx information can be made without such permission if the TDEx agency determines that:

- (a) there is an actual or potential threat of terrorism, immediate danger of death or serious physical injury to any person, or imminent harm to the national security; and
- (b) it is necessary to disseminate such information without delay to any appropriate recipient for the purpose of preventing or responding to such a threat, danger, or harm.

The Department contributing component and DOJ shall be immediately notified of any dissemination made under this exception.

28. Any requests for reports or information in R-DEx from anyone other than a party to this MOU or a TDEx agency will be directed to the Department contributing component.

Security

29. DPS must require that TDEx users undergo background checks consistent with state or agency requirements, so long as, at a minimum, those requirements included a criminal history and national fingerprint check.

30. All users shall be properly trained to use the system(s), understand the state Standard Operating Procedures, be briefed on federal and state privacy rules, and be briefed on the sharing terms specified in this MOU.

31. DPS will provide identifying information on all TDEx users with access to R-DEx to the Department for name checks and security auditing. The Department will provide identifying information on all R-DEx users with access to TDEx to DPS for name checks and security auditing. All identifying information will be treated as confidential, and will be shared only with appropriate security personnel of the Department or DPS respectively.

32. Access to and use of TDEx or R-DEx by any additional entities will be consistent with applicable state or federal law, this MOU, and the FBI CJIS Security Policy.

33. Both TDEx and R-DEx have an audit capability that will log the date, time, subject, and originating account of all user queries. The parties will maintain these audit logs for five years or for the life of the records accessed, whichever is longer. The parties will share all audit information with each other upon request.

34. The Department and DPS will exercise the degree of care appropriate to protecting sensitive law enforcement information with respect to the information obtained from TDEx and R-DEx pursuant to this MOU. Access to TDEx and R-DEx will be restricted to analysts, agents, investigators, detectives and other criminal justice officials with an official need for such information. The parties acknowledge that unauthorized disclosure of TDEx or R-DEx information could reasonably be expected to interfere with law enforcement proceedings.

Property

35. Each party is responsible for purchasing and maintaining its own equipment and facilities in relation to this MOU.

36. Unless otherwise provided herein or in an addendum, each party shall bear its own costs in relation to this MOU. Expenditures will be subject to applicable budgetary processes and availability of funds pursuant to applicable laws and regulations, including the Anti-Deficiency Act, 31 U.S.C. 1341. The parties expressly acknowledge that this MOU in no way implies that any funds will be appropriated for such expenditures.

37. If a TDEx contributing agency withdraws from TDEx, written notice will be provided to the Department at least thirty days prior to effective date of withdrawal, when possible.

Liability

38. Unless specifically addressed by the terms of this MOU, the parties acknowledge responsibility for the negligent or wrongful acts or omissions of their respective officers and employees, but only to the extent they would be liable under the laws of the jurisdictions to which they are subject.

39. This MOU is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity, against the United States or any state or local entity that is a party hereto, their departments, agencies, entities, officers, employees or agents, or any other person.

Sanctions

40. TDEx contributing agencies and DOJ participating components will duly report to DPS and the Department in writing any instance in which TDEx or R-DEx information is used in a manner inconsistent with this MOU or applicable law.

41. Any user agency or component that is determined by DPS or the Department to be in systemic or repeated violation of applicable laws and procedures governing access to and use of TDEx or R-DEx information may be denied access to TDEx and R-DEx.


42. Any person who by virtue of his employment or official position, has possession of,

or access to, agency records which contain individually identifiable information the disclosure of which is prohibited by law, agreement, rules, or regulation (including this MOU) and who, knowing that the disclosure of the information is prohibited, willfully discloses the material in any matter, including oral communication, may be subject to administrative or disciplinary action or criminal prosecution. In addition, unauthorized access or disclosure may subject the person to liability under federal or state law.


Amendment, Termination, Entry into Force and Duration

43. This MOU will remain in effect until terminated or modified by the parties.
44. Except as otherwise provided, this MOU may be amended by the mutual written consent of the parties authorized representatives.
45. This MOU may be terminated at any time upon the mutual written consent of the parties. In the event that both parties consent to terminate this MOU, the parties will consult prior to the date of termination to ensure termination on the most economical and equitable terms.
46. Either party may terminate this MOU upon 30 days written notice to the other party. Such notice will be the subject of immediate consultation by the parties to decide upon the appropriate course of action. In the event of such termination, the following will apply:
 - (a) the terminating party will continue participation, financial or otherwise, up to the effective date of termination;
 - (b) each party will pay the costs it incurs as a result of termination; and
 - (c) all rights, obligations, responsibilities, limitations, and other understandings with respect to the disclosure and use of all information received during a party's participation in this MOU shall survive any termination.

In witness thereof, the parties have executed this MOU by the signatures of the duly authorized officials from DOJ and DPS.
