Any contract found to violate Government Code 2261.252 is void.

Change orders will be allowed only if unforeseen conditions arise such as, but not limited to, increasing quantities or if the department needs dictate changes. All change orders must be in writing with a Purchase order Change Notice (POCN) issued by Procurement and Contract Services.

U.S. Department of Homeland Security E Verify System
