All changes shall be in the scope of original work. No verbal change orders will be permitted. All change orders must be in writing with a Purchase order Change Notice (POCN) issued by Procurement and Contract Services.

1. Replace a broken 2 inch valve with a Rainbird valve.
2. Repair a broken 2 inch mainline in the back of the property.
3. At the Driver License Office move four (4) heads approximately twelve (12) inches each to new locations which will allow the bedded areas to receive water along with the grass area.

U.S. Department of Homeland Security E Verify System
