If this certification is falsely made, the Contract may be immediately terminated, at the discretion of the state and at no fault to the state, with no prior notification. The Contractor shall also be responsible for the costs of any re-solicitation that the state must undertake to replace the terminated Contract. Installation location requires controlled access.

Contractors and sub contractors will be required to submit to a Criminal History Background Check.

Contractors will be required to meet the attached Texas Department of Public Safety Terms and Conditions.
