# Introduction

Since its inception in 1930, the Uniform Crime Reporting (UCR) program has presented summary-based totals for the main index crimes (i.e., Murder, Rape, Robbery, Aggravated Assault, Burglary, Motor Vehicle Theft, and Larceny/Theft). Arson and Human Trafficking were later added. While the program has matured to the more-detailed National Incident-Based Reporting System (NIBRS) methodology, summarized totals are still used for several reasons: (1) ease of comparison to historical data and the Federal Bureau of Investigation's (FBI's) Crime Data Explorer, (2) to allow a consistent representation of crime data across the states, as nationwide adoption of NIBRS reporting data is still relatively low, and (3) for a quick view of crimes against persons and property.

The Texas UCR program serves as the state repository for the collection of crime statistics. The program's primary objective is to generate reliable information for law enforcement administration, operation, and management. Policymakers and members of the public, including the media and academia, rely upon this data to understand year-to-year fluctuations in crime levels in their communities across the state.

The Texas Department of Public Safety (DPS) supports accuracy in reporting through training and quality control checks on the data submissions it receives from the more than 1,500 law enforcement agencies. While DPS takes steps to verify the validity of incoming data, each reporting agency is responsible for adhering to established standards and correcting any errors in their submissions.

The annual Crime in Texas publication provides a static year-to-year comparison and four-year data trends. This year's report

was limited to four-year comparisons to utilize the fully NIBRS data that began in 2021. DPS has also developed an online tool, the UCR Crime in Texas portal, to offer on-demand access to the richer crime data being reported. The online tool can be found at <https://txucr.nibrs.com/>.

With the release of the 2024 Crime in Texas report, DPS is beginning a two-year transition to streamline the annual report. Future editions will focus on overall crime trends and highlight the Top 25 Jurisdictions by population size and/or crime volume.

To continue promoting transparency and public access to detailed data, DPS will launch an updated Crime in Texas section on the UCR Crime in Texas Portal. This online resource will house year-to-year comparison reports, standardized reports, and allow users to generate customized queries of data previously included in the annual publications.

This shift will reduce the time and resources required to produce the annual publication, allow DPS to focus more on data quality and analysis, as well as facilitate more user-centric access to crime data through the public portal.

For inclusion in this 2024 Crime in Texas report, data must have been reported by March 14, 2025. The information in this publication is retrieved from local agency NIBRS reports. The UCR portal presents both NIBRS and summary-format data. While the annual publication reflects a static snapshot, the portal displays dynamic data that may be updated as agencies submit or revise records.

Due to the nature of the crime statistics collected, some demographic information for the offender and/or victim may be unknown or partially unknown.

# Reporting is Now Mandated by Texas Statute

The annual Crime in Texas report analyzes reported crime incidents using data from participating law enforcement agencies that submit information to the Texas UCR program. DPS also uses this data to produce ad hoc reports and fulfill public information requests throughout the year. DPS program staff actively monitor submissions for anomalies and collaborate with agencies to ensure data accuracy.

Historically, the UCR program was voluntary, leading to inconsistent monthly data submissions, which hampered the ability of state and municipal governments, law enforcement agencies, academic entities, and the public to obtain a reliable depiction of crime in Texas.

The 88th Texas Legislature (2023) enacted amendments to Texas Government Code §411.054 mandating local law enforcement agencies (1) implement a NIBRS compliant reporting system, and (2) use that reporting system to submit NIBRS data to the Texas UCR program. After the law went into effect in 2023, 343 additional agencies began participating in the program.

## Measuring Crime in Texas by Volume and Rate

The Crime in Texas report presents both the rate and volume of crimes. The crime rate is the number of identified offenses per 100,000 people, which allows for consistent comparisons between years and among agencies of different sizes. The FBI provides yearly population estimates for each reporting jurisdiction based on Census Bureau data. Crime volume, on the other hand, is simply the total number of reported incidents.

## Texas-Specific Reporting Requirements

In addition to the index crimes, the report also includes data related to Texas offense categories and offense indicators that agencies are required to report. These categories and indicators are Sexual Assault (category), Drug Seizures (category), Family Violence (indicator), and Hate Crime (indicator).

# Clearances

An offense is cleared when a law enforcement agency arrests an offender for the offense. The arrest of one person can clear several crimes or several persons may be arrested in the process of clearing one offense.

Law enforcement agencies may also clear a crime by exceptional means when all four of the following criteria are met: (1) The agency has established the identity of the offender; (2) enough evidence exists to support an arrest, charge, and turning over to the court for prosecution; (3) the exact location of the offender is known so that the subject could be taken into custody now; and (4) some element beyond law enforcement control precludes arresting, charging, and prosecuting the offender.

Clearances are reflected in the same year the incident was reported, regardless of when the offense was cleared. For example, if a case is cleared in 2024 for a 2023 incident, the clearance will be included in the 2023 clearance totals, not in the 2024 statistics.

## Additional Notes for Data Throughout this Report

(1) Due to rounding and statistical insignificance, some percentage values within the report may appear as 0.0.

(2) Due to rounding, some crime rates and percentages are shown as one decimal place and may not add up to 100% or match combined subtotals.

(3) Population totals reflect participating agency jurisdictions, not the overall Texas population.

(4) The FBI only provides population estimates for city police departments (PDs) and county sheriff offices (Co SOs). In heavily populated areas, the population is assigned to city police departments, and there is no remaining population assigned to the county sheriff's office.

(5) Some agency types overlap jurisdictions with the city or county and not assigned population by the FBI and are considered "Zero Population" agencies. Crime rates cannot be calculated for these agencies.

# At a Glance, 2024

Crime volume is the aggregate sum of the offenses within the crime index. By comparing the crime volume from year to year, trends in the number of crimes committed can be studied and analyzed.

# At a Glance, 2024 (Cont.)

## Crime Rate

Crime rates are compiled to compensate for changes in Texas' population and show the number of people affected by crime within a given population. Texas crime rates are expressed as the number of crimes per 100,000 persons. While the FBI estimates show a decline in the State's population density in the major cities, the data shows a shift in population into surrounding cities and county areas.

# Top 25 by Highest Jurisdictional Population & Crime Volume

The Crime in Texas report uses FBI population estimates for Texas jurisdictions to calculate crime rates and for consistency in reporting. Population trends show that Texas continues to be one of the fastest growing states. While the FBI estimates show a decline in the State's population density in the major cities, the data shows a shift in population into surrounding cities and county areas.

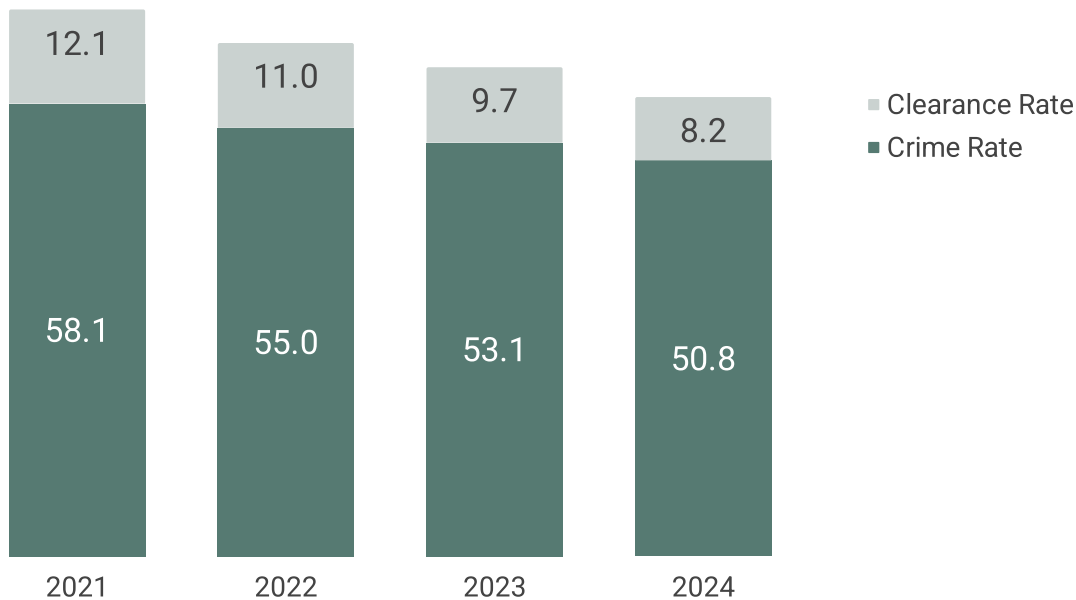

# Human Trafficking - Involuntary Servitude & Commercial Sex Acts (Combined) and Clearance Rates, Current Data by Year



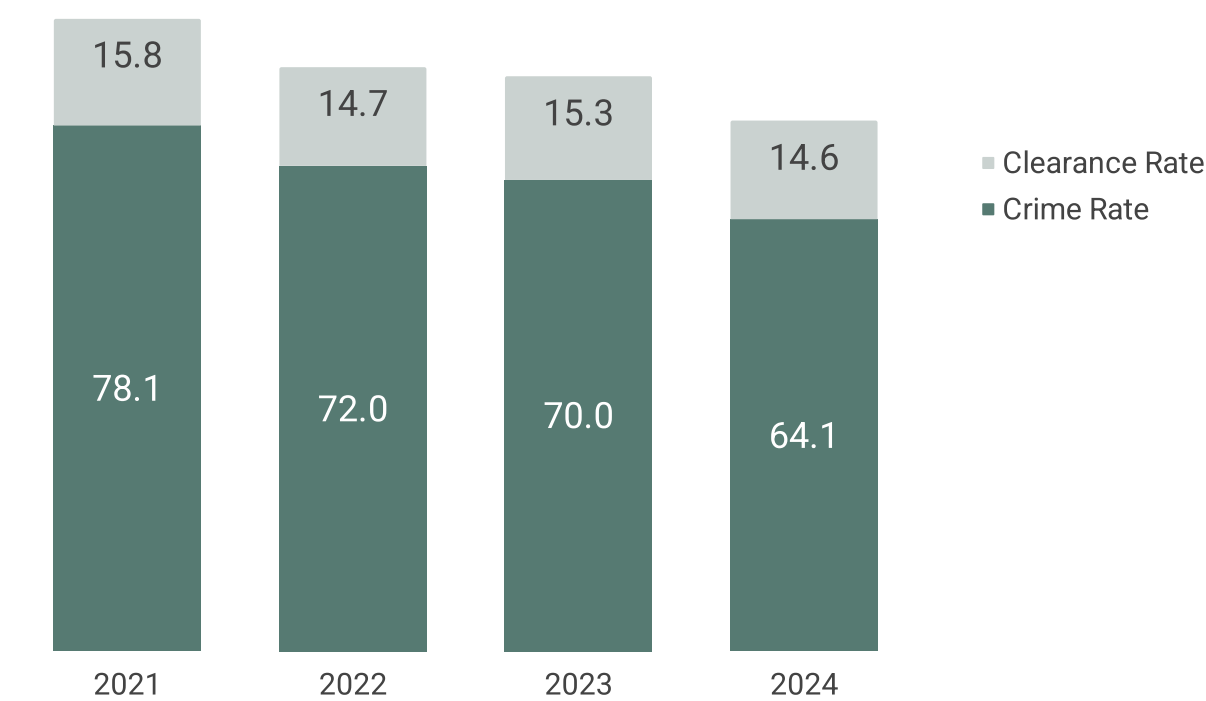

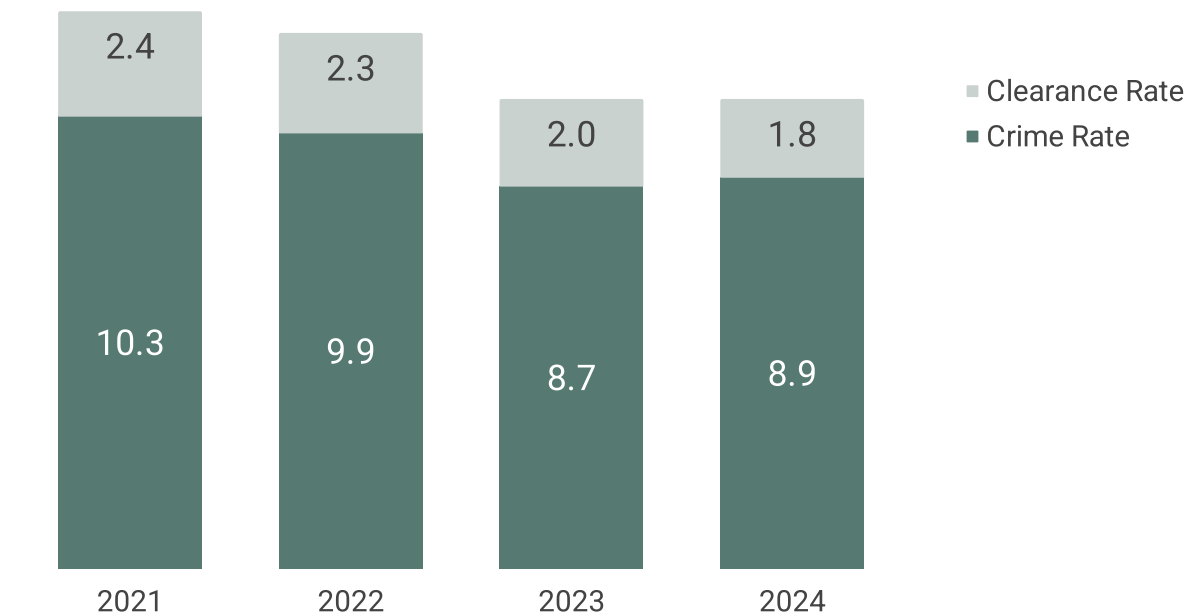

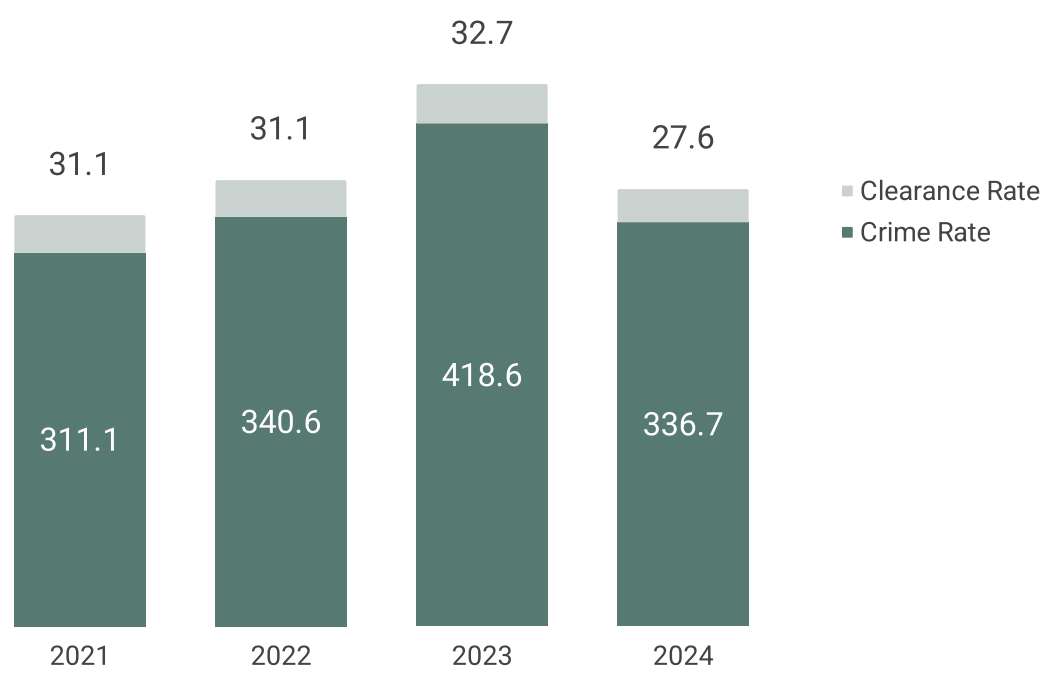

# Motor Vehicle Theft and Clearance Rates, Current Data by Year



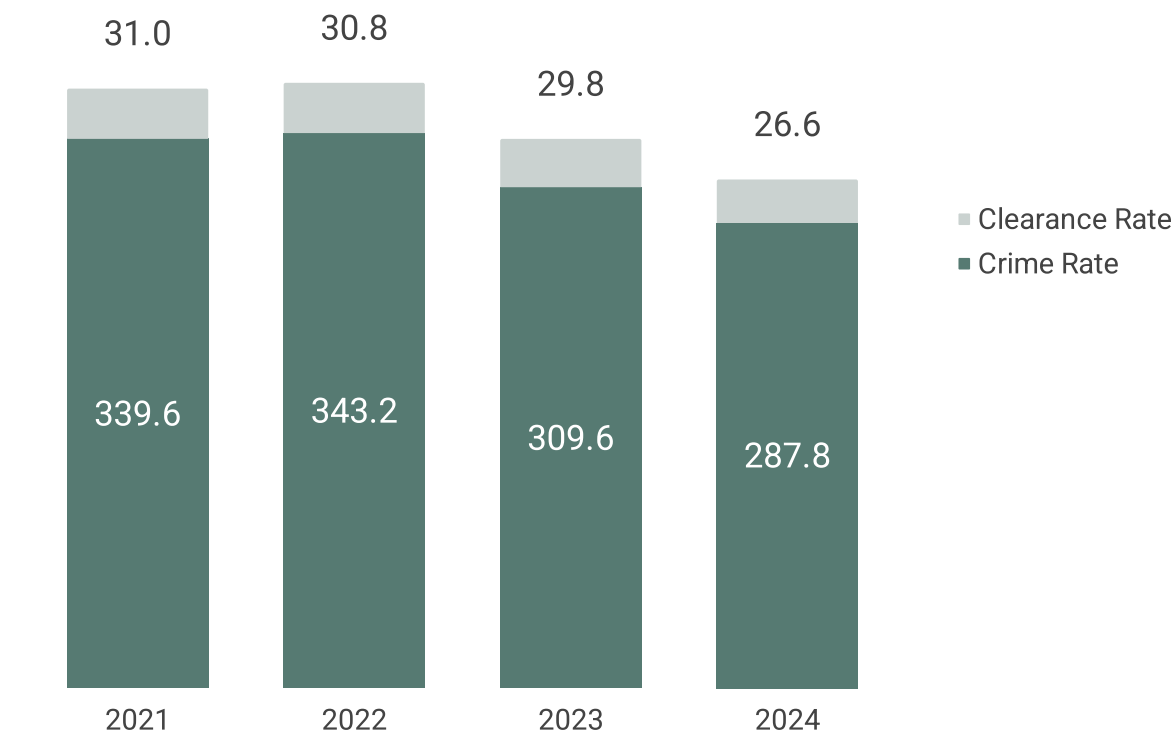

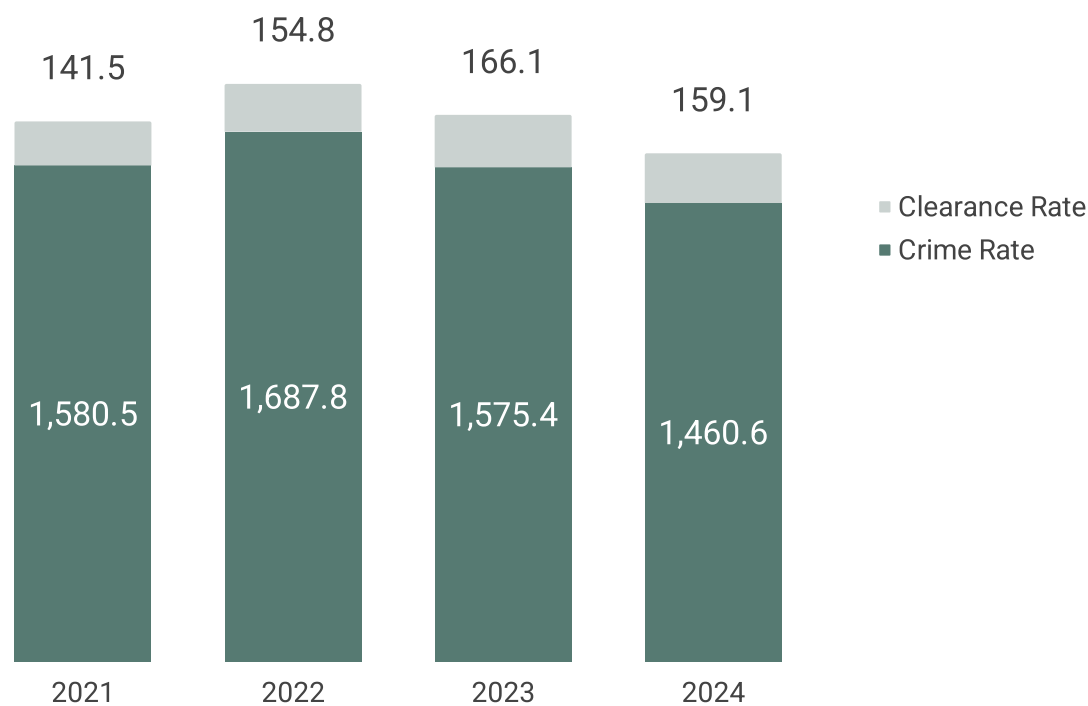

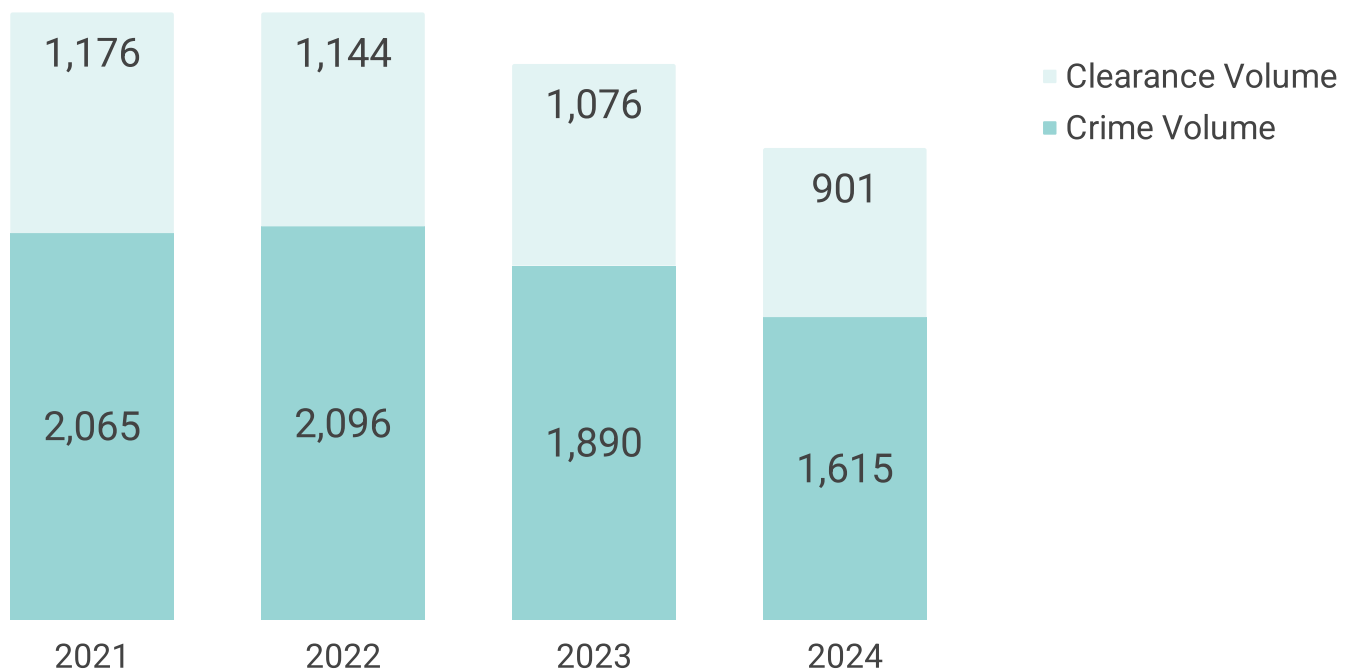

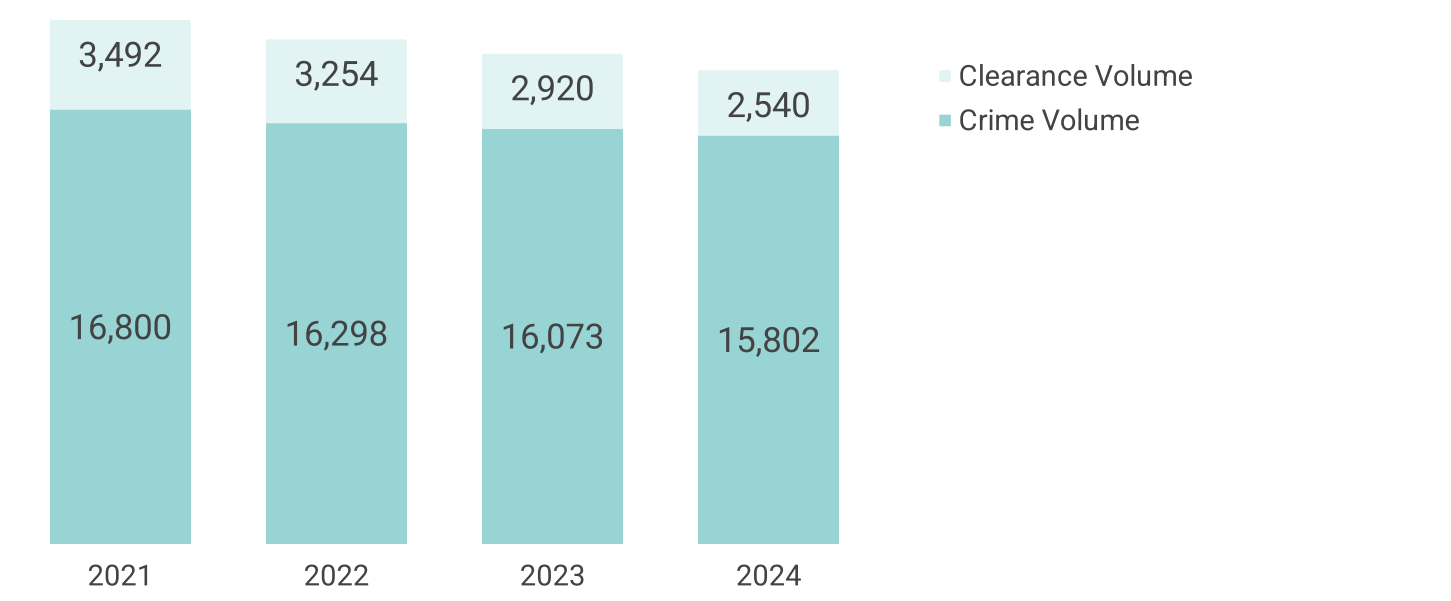

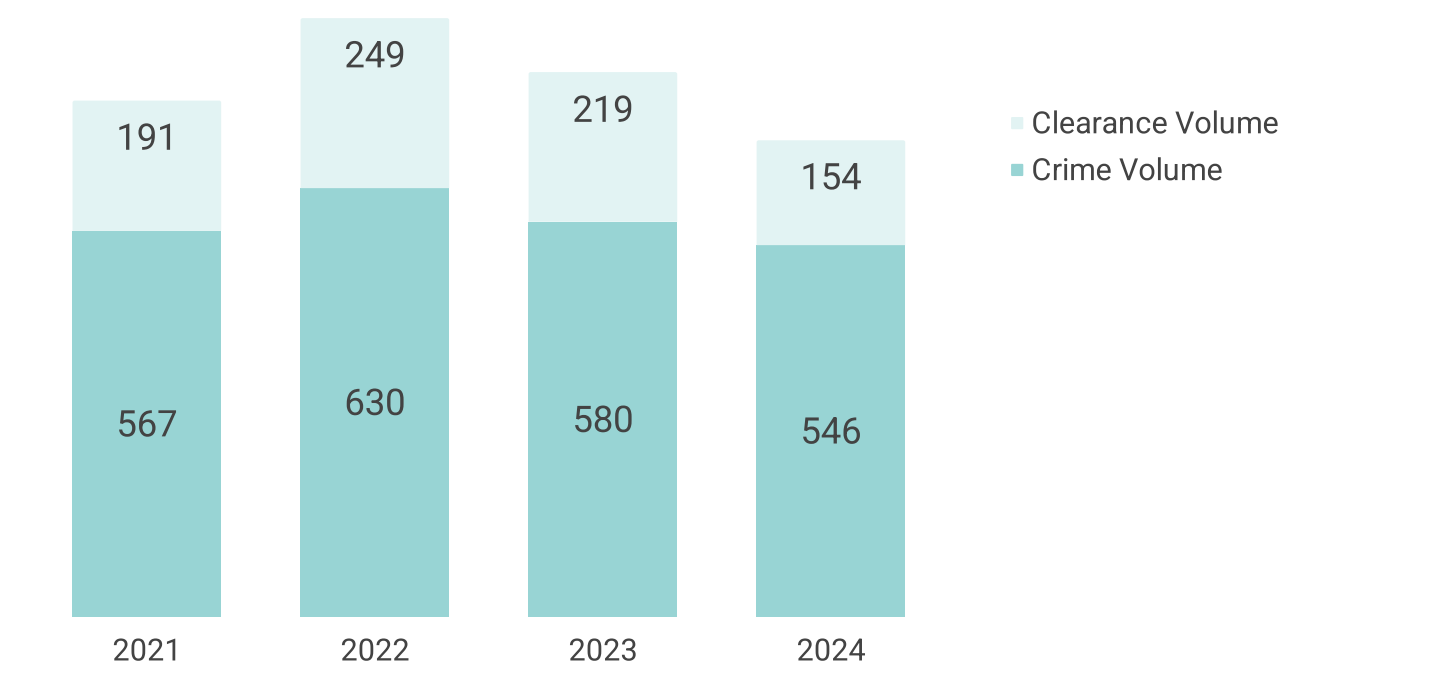

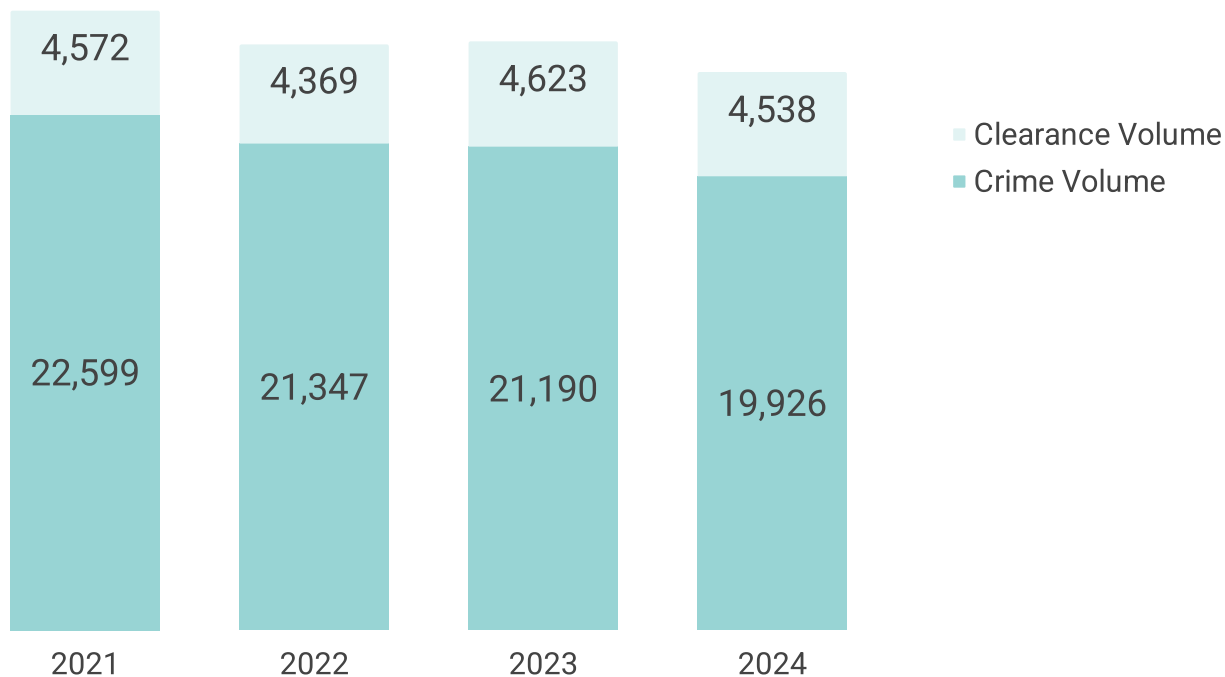

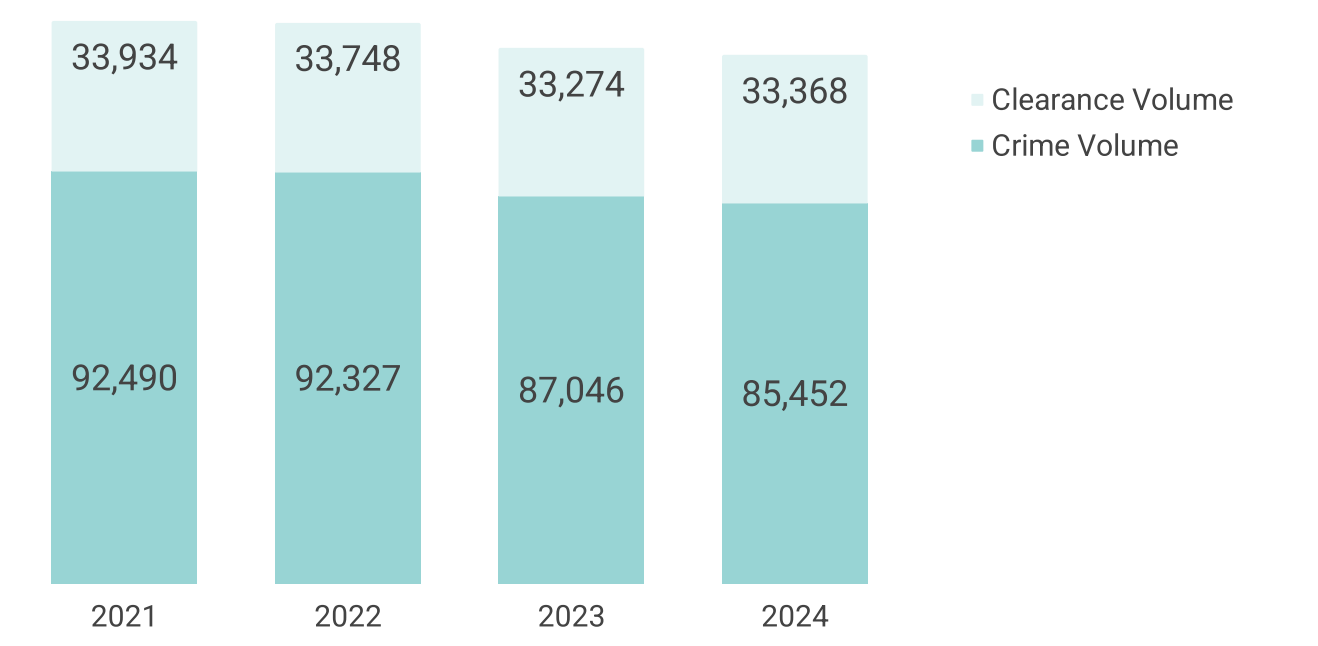

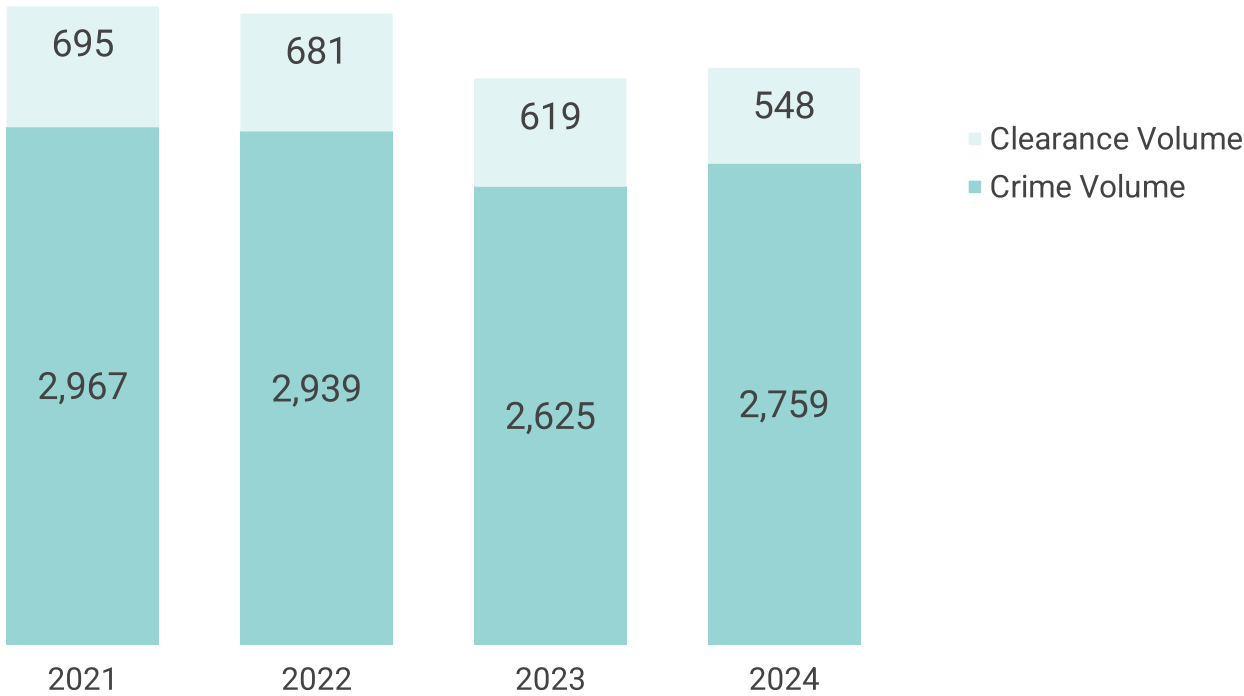

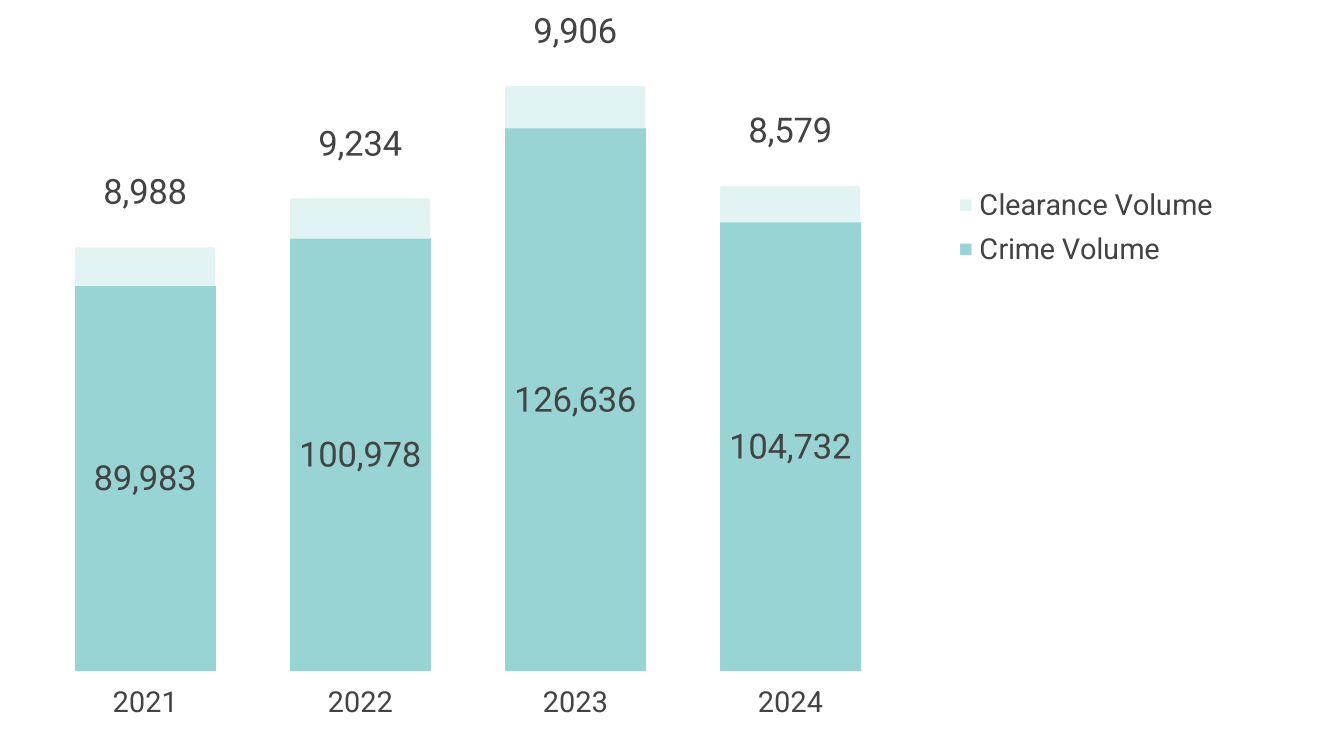

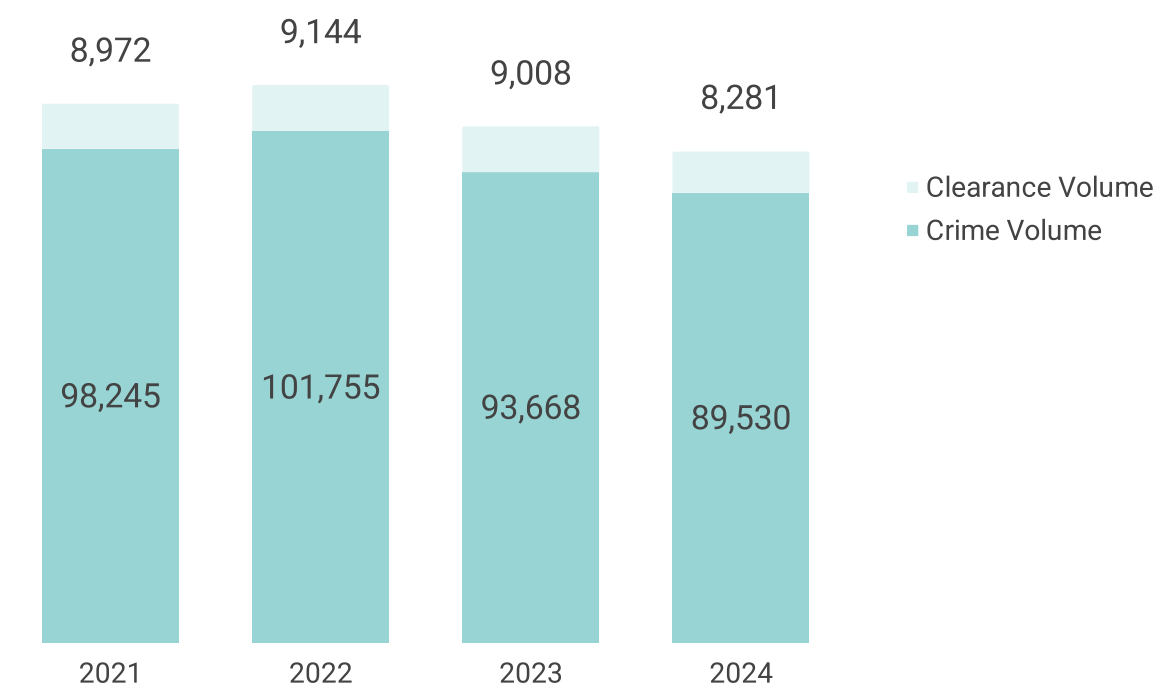

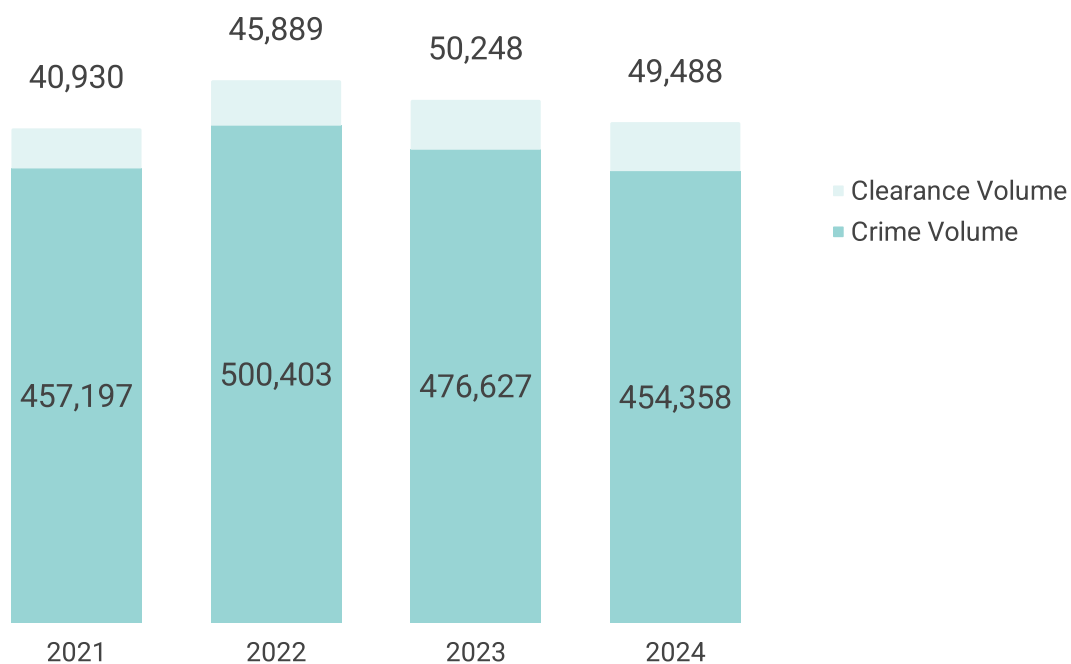

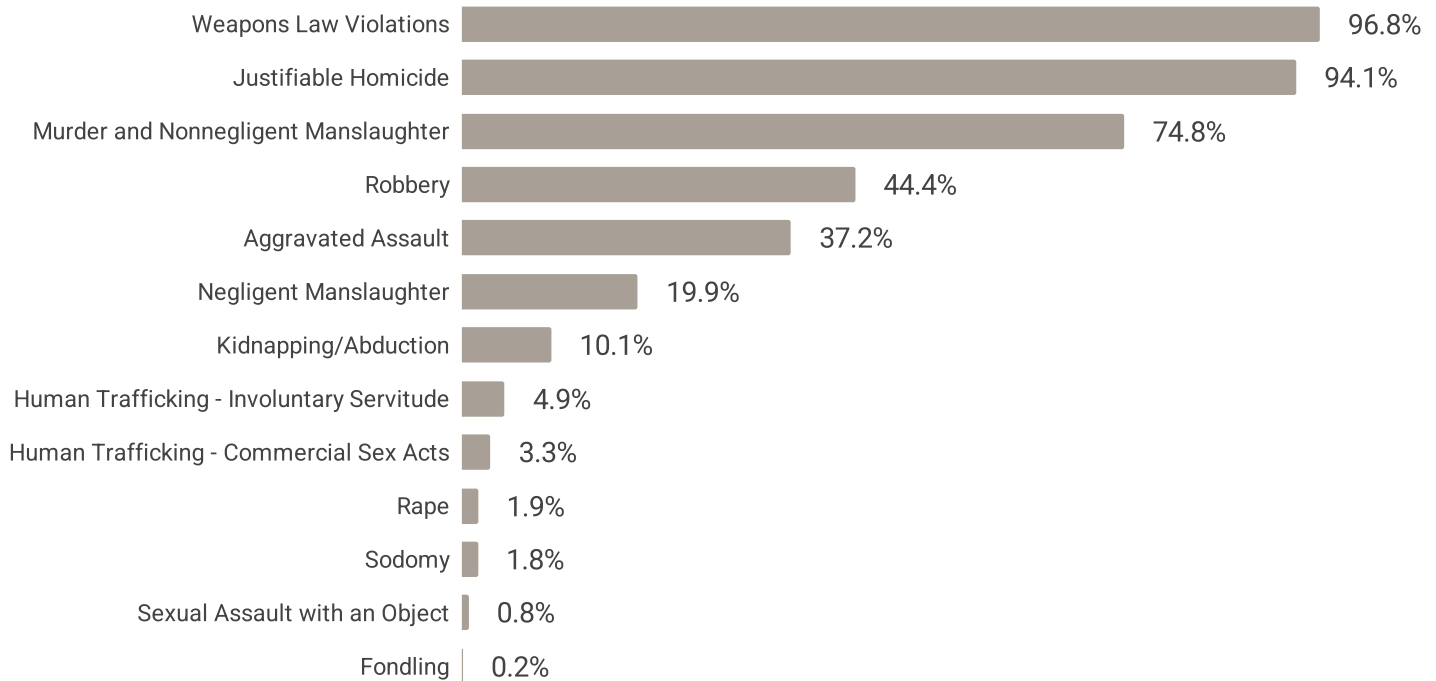

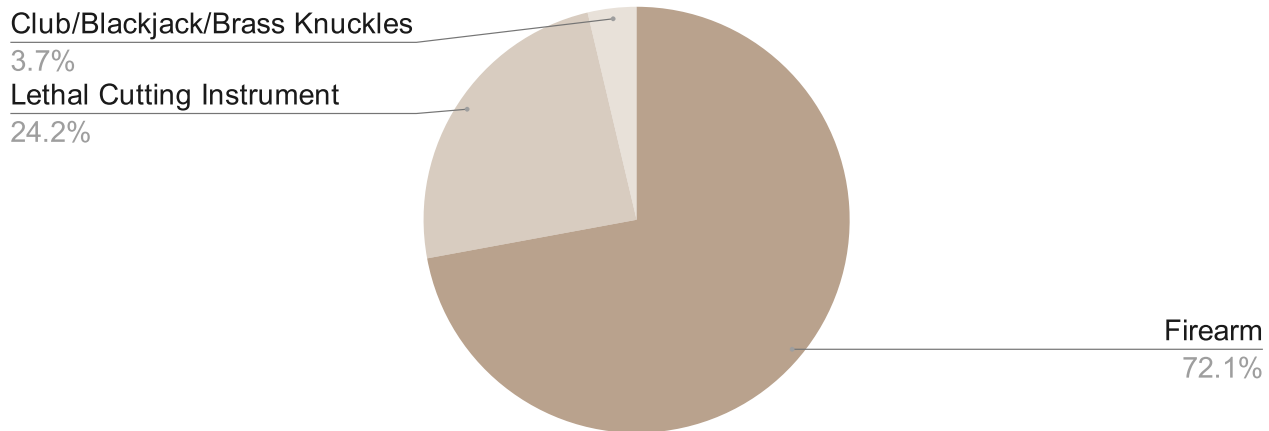

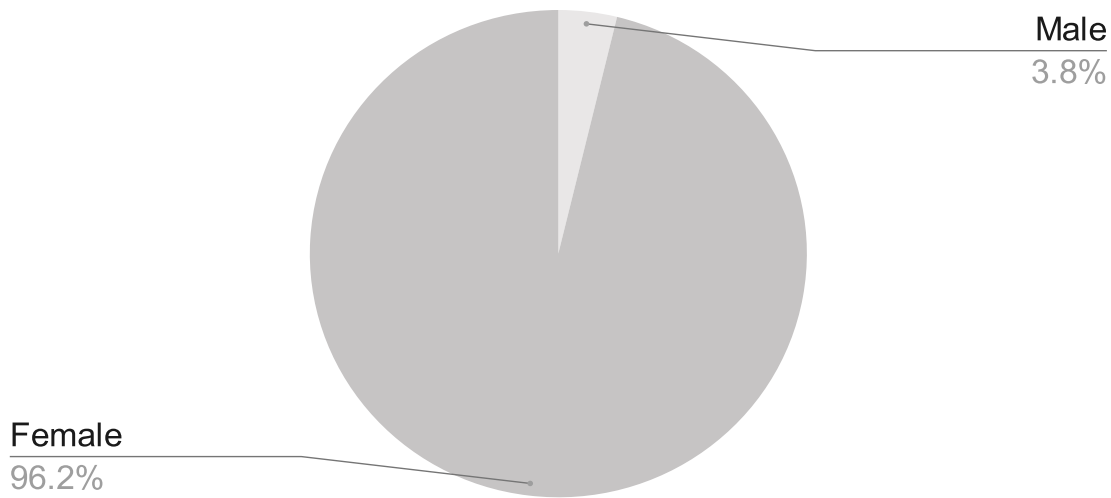

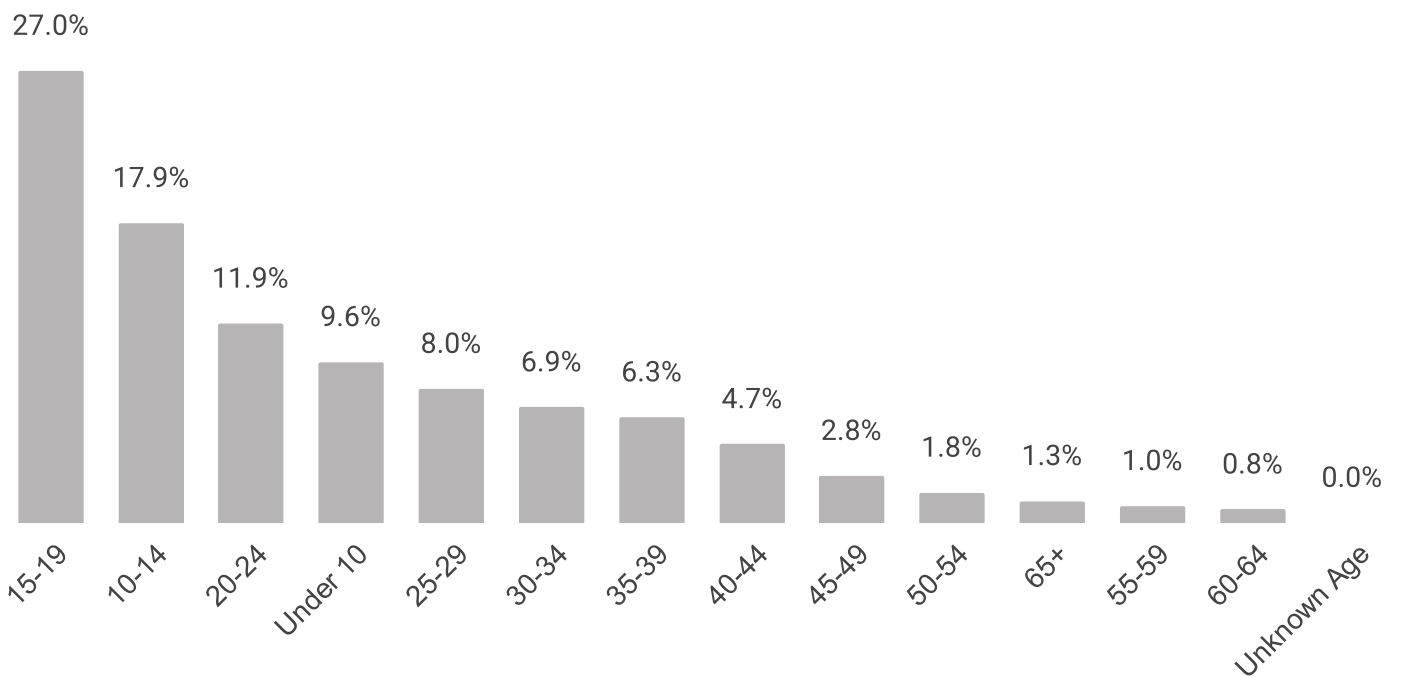

## Percent of Victim Age, Rape



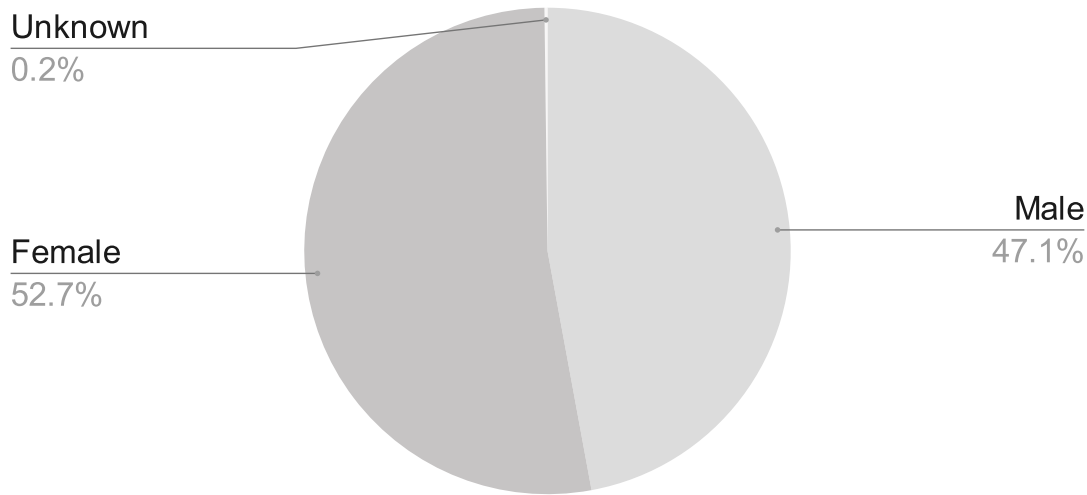

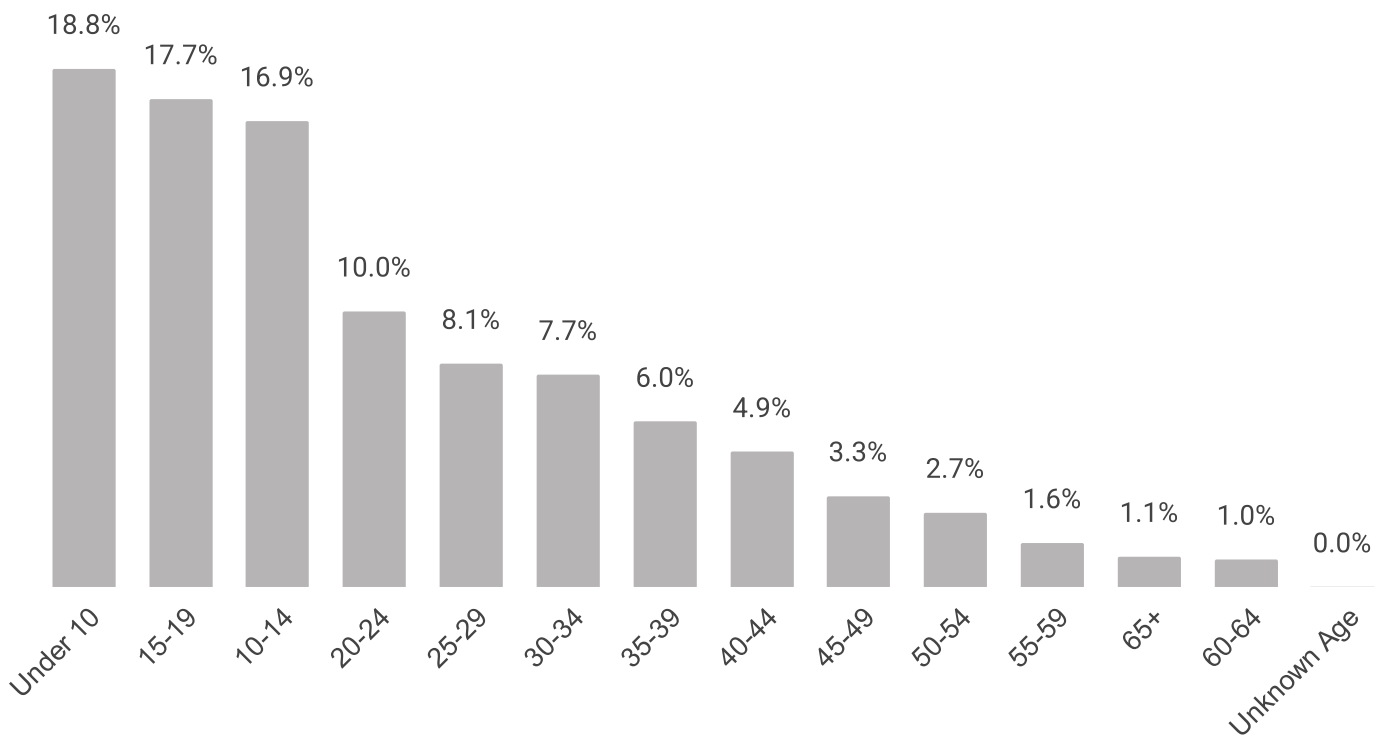

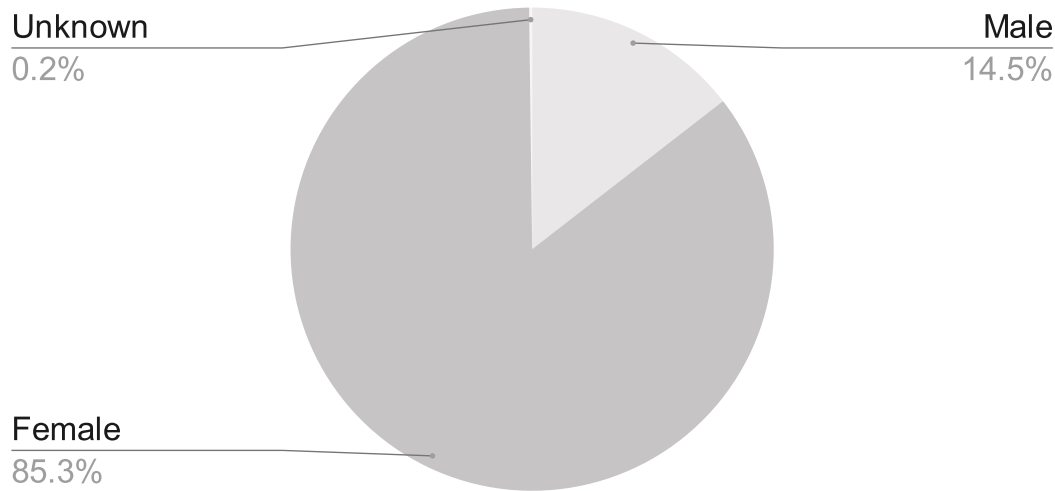

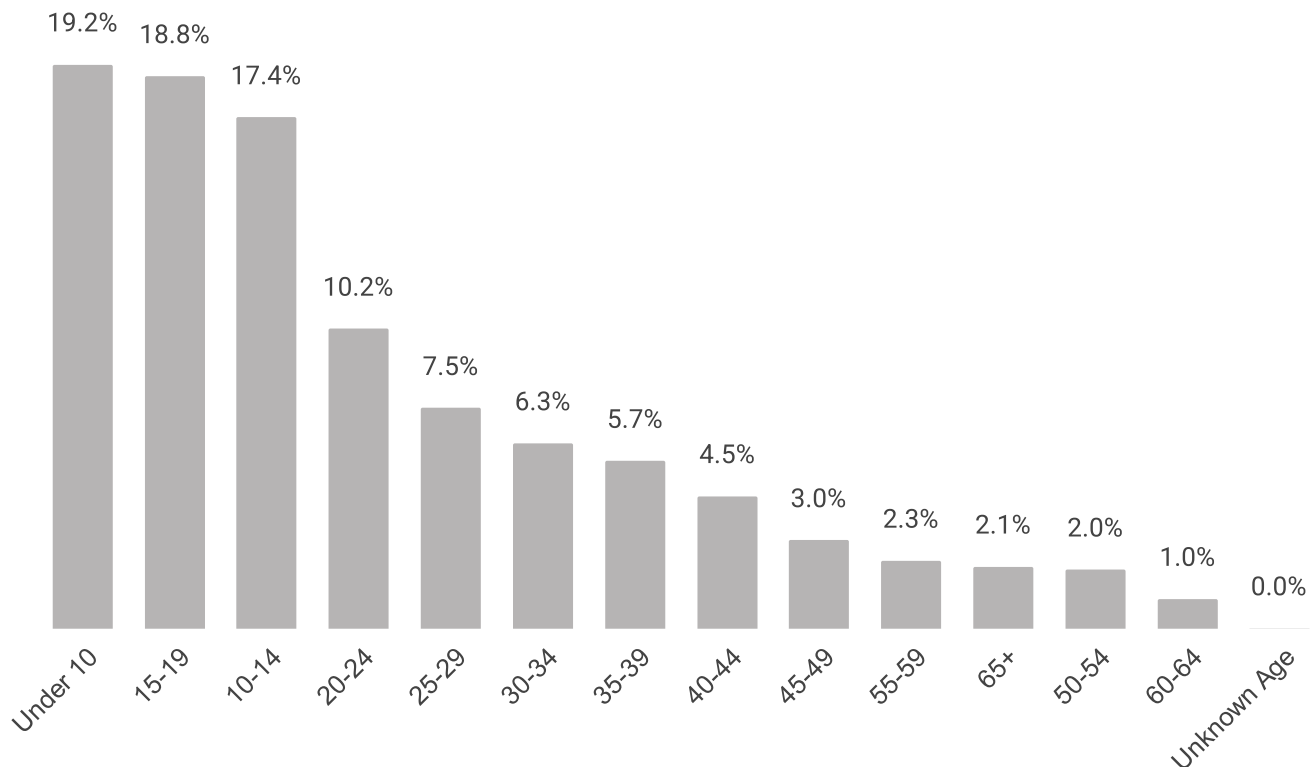

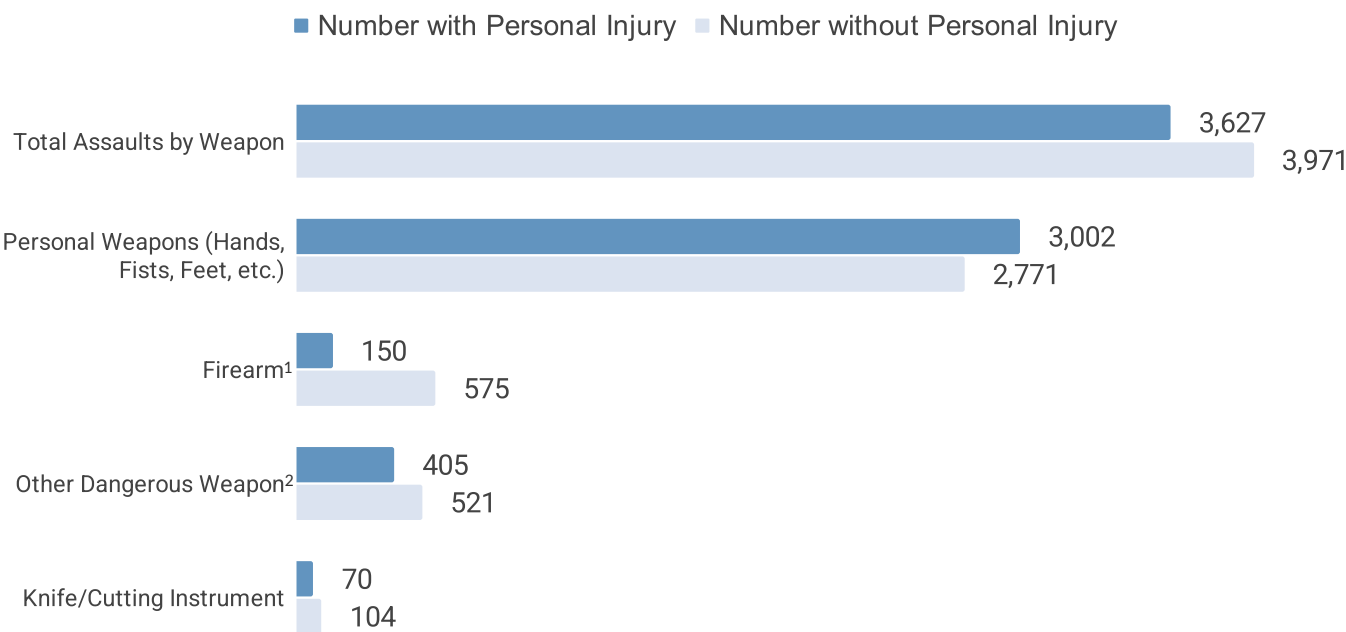

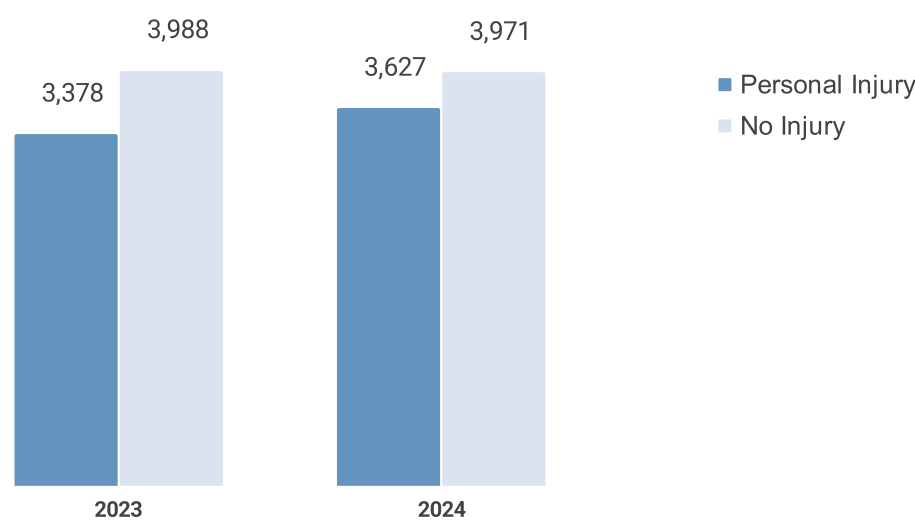
## Officer Injury by Weapon Type



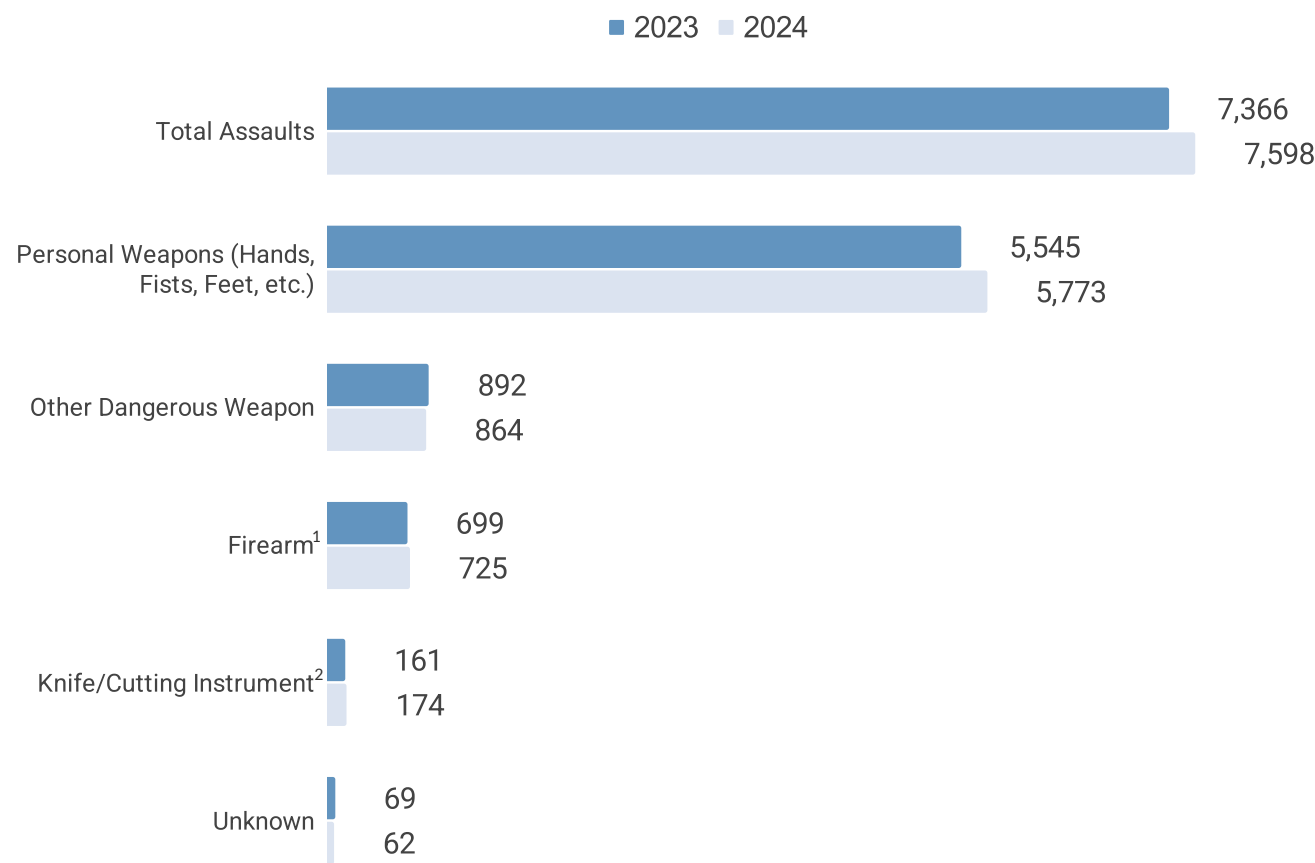

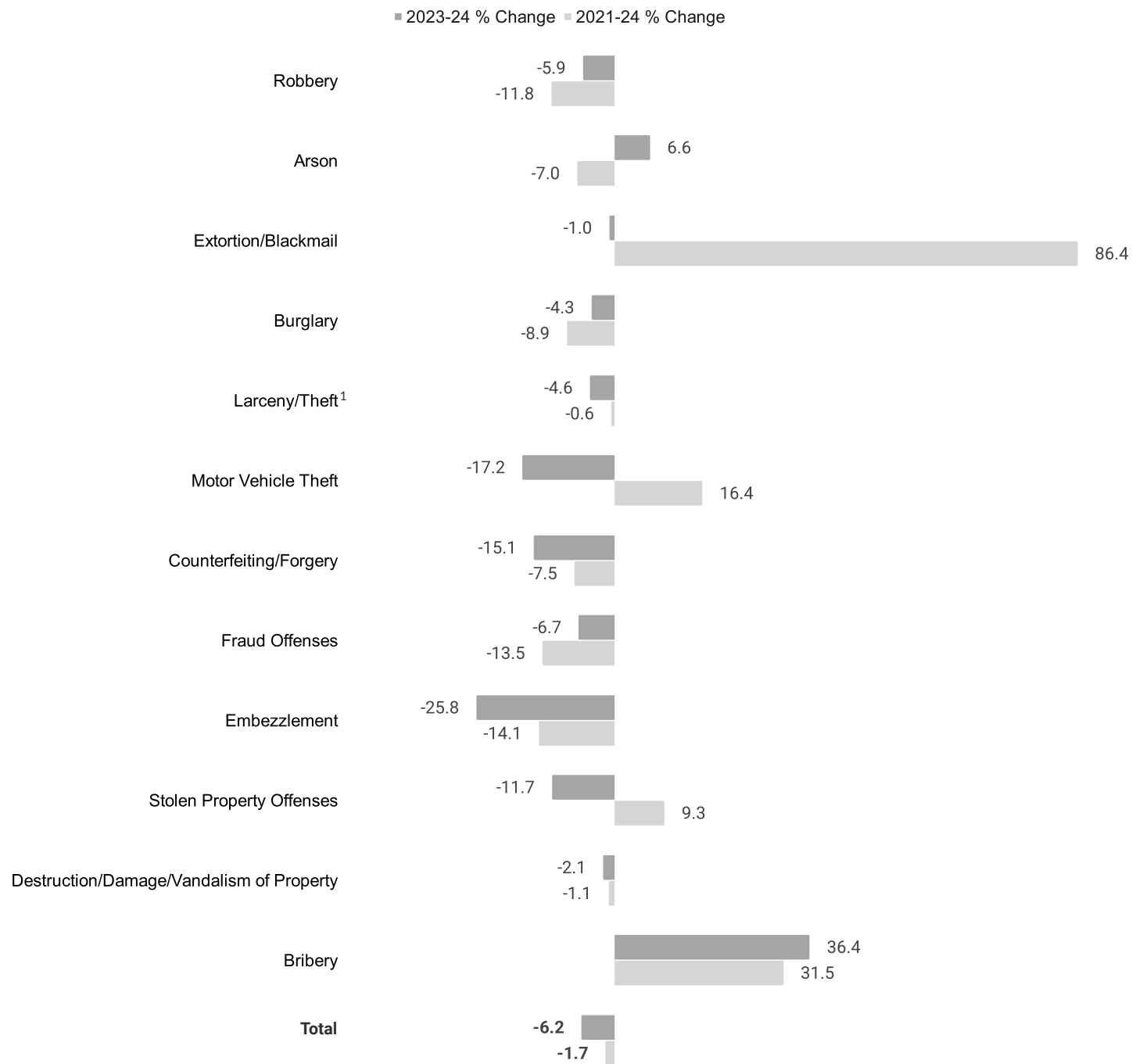

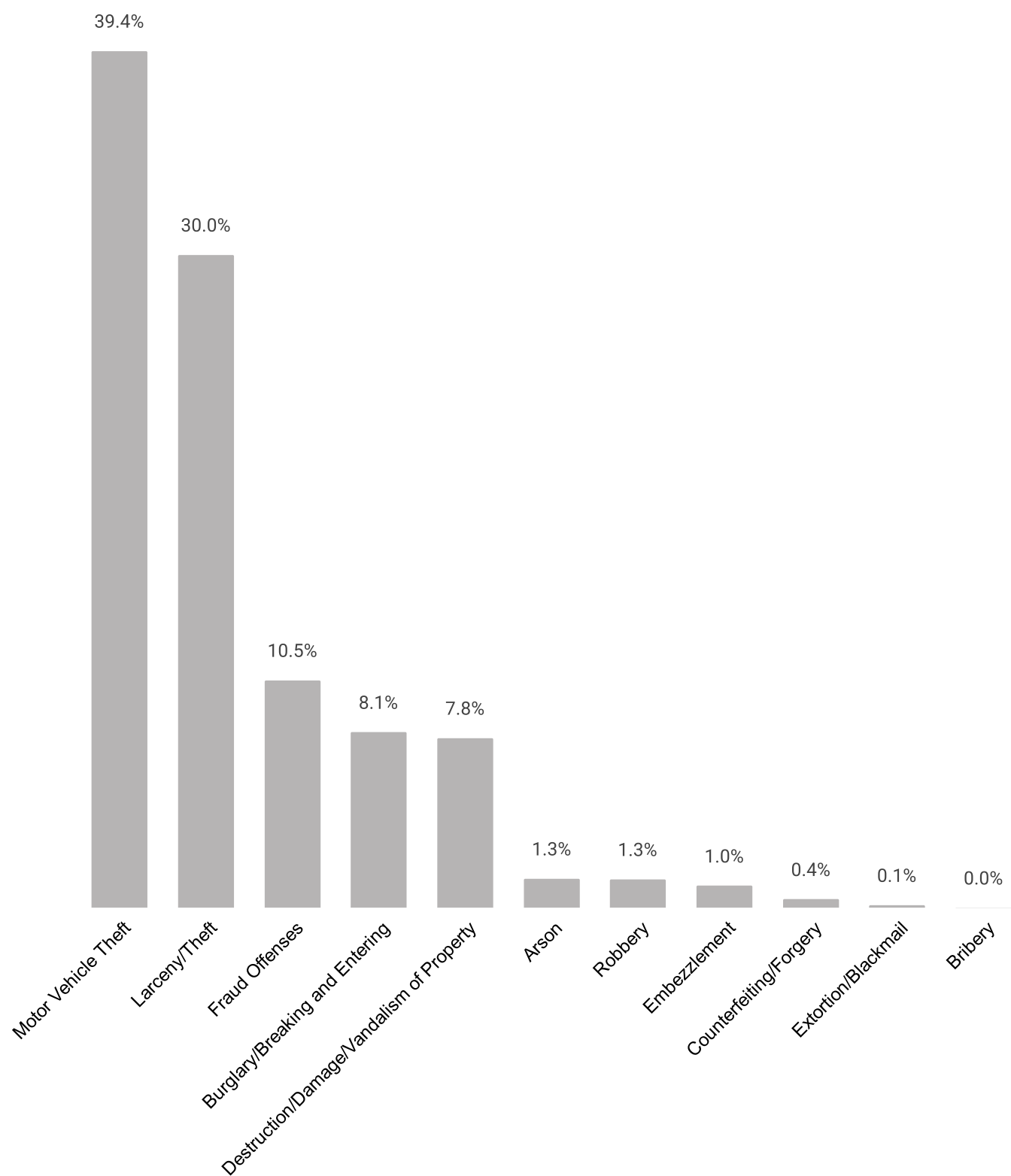

Property Loss Value, Percent of 2024 Total

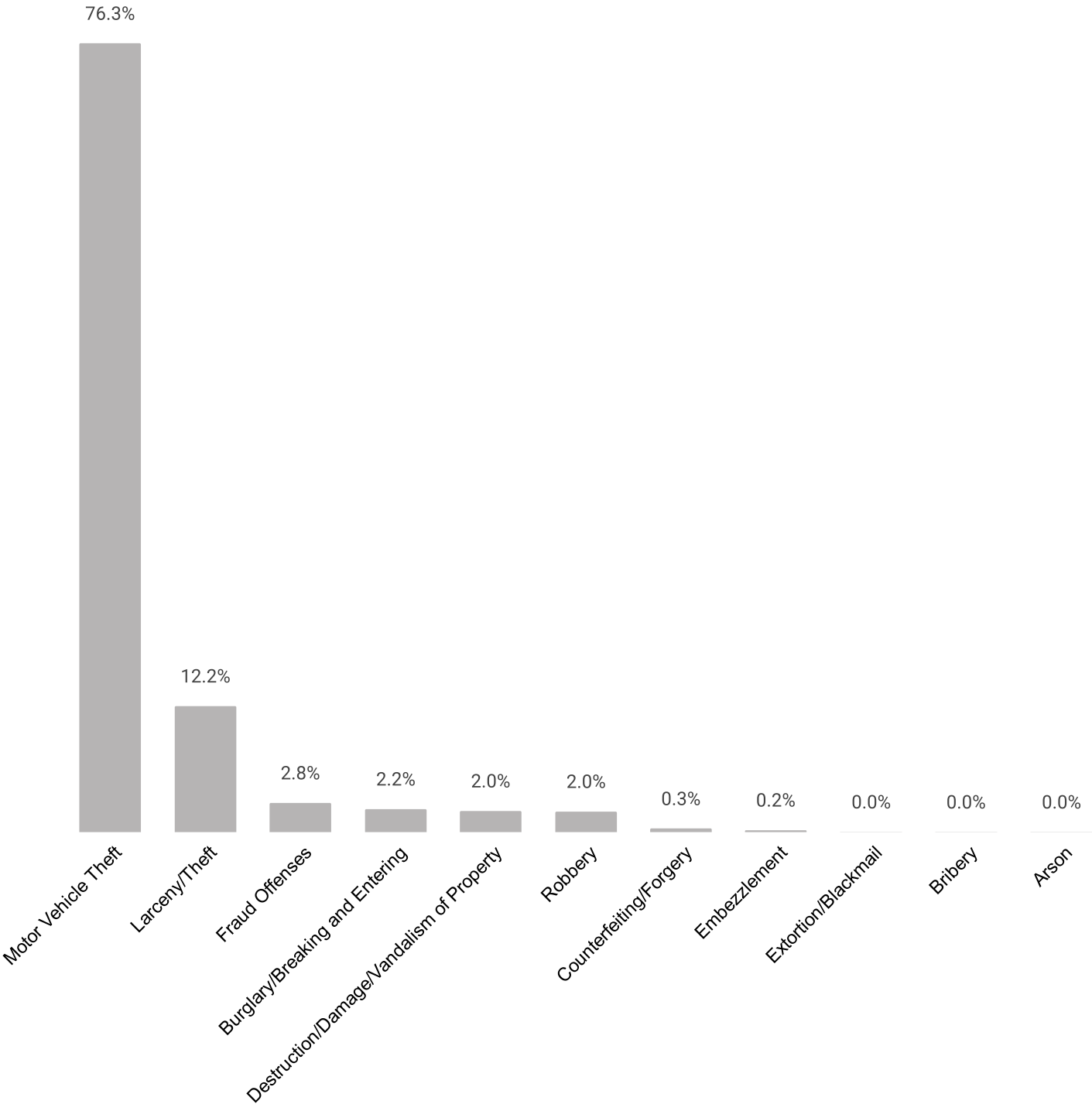

# Glossary

The following is a collection of terms and definitions as they relate to Texas criminal offenses, federal National Incident Based Reporting System (NIBRS) guidelines/offenses and the Uniform Crime Reporting (UCR) Program.

## Adult

In Texas, an adult is a person 17 years of age or older. Federal law provides that an adult is a person 18 years of age or older. Unless otherwise indicated, this publication follows the state definition for adult.

## Affinity

The connection existing, as a consequence of marriage, between married persons and the kindred of the other.

## Aggravated Assault

An unlawful attack by one person upon another wherein the offender uses a weapon or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness. This also includes assault with disease (as in cases when the offender is aware that he/she is infected with a deadly disease and deliberately attempts to inflict the disease by biting, spitting, etc.).

## All Other Offenses

All violations of state and/or local laws, except crimes that fall under another UCR offense category and traffic offenses. This is a Group B offense and only arrest information is reported.

## Arson

To unlawfully and intentionally damage, or attempt to damage, any real or personal property by fire or incendiary device, with or without intent to defraud.



## Bribery

The offering, giving, receiving, or soliciting of anything of value (i.e., a bribe, gratuity, or kickback) to sway the judgment or action of a person in a position of trust or influence.

## Burglary/Breaking and Entering

The unlawful entry into a building or other structure with the intent to commit a felony or a theft.

## Cargo Theft

Cargo theft in UCR refers to taking possession illegally of any cargo shipment including but not limited to the following categories: cargo shipment of goods, chattels, money, baggage that constitutes, in whole, in part, a commercial shipment of freight moving in commerce, from any pipeline system, railroad car, motor truck, other vehicle, from any tank, storage facility, station house, platform, depot, from any vessel, wharf, from any aircraft, air terminal, airport, aircraft terminal, air navigation facility, from any intermodal container, intermodal chassis, trailer, container freight station, warehouse, freight distribution facility, freight consolidation facility. For purposes of this definition, cargo shall be deemed as moving in commerce at all points between the point of origin and the final destination, regardless of any temporary stop while awaiting transshipment or otherwise.

## Crime Factors

Conditions that affect the amount and type of crime that occurs in a geographical area.

## Crime Index

The sum of seven index offenses used to measure the extent, fluctuation, and distribution of crime in a given geographical area. Crime classifications used in the Crime Index are the following: murder, rape, robbery, aggravated assault, burglary, larceny/theft, and motor vehicle theft. Arson and human trafficking are also classified as index offenses but are not part of the Crime Index.

## Crime Rate

The number of offenses per 100,000 inhabitants. To calculate the crime rate, divide the number of offenses by the population and then multiply by 100,000. The crime rate is useful in determining the relative frequency of crime without regard to fluctuations in population.

## Crime Volume

Crime volume is the aggregate sum of the offenses within the crime index.

## Curfew/Loitering/Vagrancy Violations

The violation of a court order, regulation, ordinance, or law requiring the withdrawal of persons from the streets or other specified areas; prohibiting persons from remaining in an area or place in an idle or aimless manner; or prohibiting persons from going from place to place without visible means of support. These are Group B offenses and only arrest information is reported.

## Disorderly Conduct

Any behavior that tends to disturb the public or decorum, scandalize the community, or shock the public sense of morality. This is a Group B offense and only arrest information is reported, unless this is related to one of the Texas Penal Code sex offenses.

## Driving Under the Influence (DUI)

Driving or operating any motor vehicle or common carrier while mentally or physically impaired as the result of consuming an alcoholic beverage or using a drug or narcotic. This is a Group B offense and only arrest information is reported.

## Drug Abuse Violations

All arrests for violation of state and/or local laws, specifically those relating to the unlawful cultivation, manufacture, distribution, sale, purchase, use, possession, transportation and/or importation of any controlled drug or narcotic substance.

## Ethnicity (Ethnic Origin)

In UCR, race and ethnic origin are counted as two separate designations. The ethnic origin categories were adopted from the U.S. Department of Commerce and are Hispanic and not Hispanic. Included as Hispanic are all persons of Mexican, Puerto Rican, Cuban, Central or South American, or other Spanish culture or origin, regardless of race. Ethnicity is an optional data element.

## Extortion/Blackmail

To unlawfully obtain money, property, or any other thing of value, either tangible or intangible, through the use or threat of force, misuse of authority, threat of criminal prosecution, threat of destruction of reputation or social standing, or through other coercive means.

## Family

For UCR purposes, is defined as individuals related by blood, affinity, marriage, former marriage,

biological parents of the same child, foster children, foster parents, members of the same household or former members of the same household.

## Family Violence

An act by a member of a family or household (as defined by the Texas Family Code) against another member that is intended to result in physical harm, bodily injury, assault, or a threat that reasonably places the member in fear of imminent physical harm. In addition to the NIBRS definition, this also includes “Dating Violence” per Texas mandate.

## Forgery and Counterfeiting

The altering, copying, or imitation of something, without authority or right, with the intent to deceive or defraud by passing the copy or thing altered or imitated as that which is original or genuine; or the selling, buying, or possession of an altered, copied, or imitated thing with the intent to deceive or defraud. Includes attempts.

## Fraud

The intentional perversion of the truth for the purpose of inducing another person, or other entity, in reliance upon it to part with something of value or to surrender a legal right. This excludes Forgery and Counterfeiting, as the FBI assigned those their own offense.

## Gambling

Promoting, permitting, or engaging in illegal gambling.

## Embezzlement

The unlawful misappropriation by an offender to his/her own use or purpose of money, property, or some other thing of value entrusted to his/her care, custody, or control. Includes attempts. In general, an employer/employee or legal agent relationship must exist for Embezzlement to occur.

## Hate Crime Bias Motivation

Hate crime bias motivation, relates to crimes where the offender(s) are motivated by prejudice, hatred, or advocacy of violence. The offender’s bias motivation must be against one of the protected classes, as defined by the FBI, regardless of whether the victim was part of that or any protected class.

## Hierarchy Rule

For SRS submissions, when several offenses are committed simultaneously by one person or group of persons, the hierarchy rule in UCR mandates that only the most serious offense is recorded for statistical purposes. Arson is an exception to this rule.

## Human Trafficking

Human Trafficking includes both Commercial Sex Acts and Involuntary Servitude.

## Commercial Sex Acts

Inducing a person by force, fraud, or coercion to participate in commercial sex acts, or in which the person induced to perform such act(s) has not attained 18 years of age.

## Involuntary Servitude

The obtaining of a person(s) through recruitment, harboring, transportation, or provision, and subjecting such persons by force, fraud, or coercion into involuntary servitude, peonage, debt bondage, or slavery (not to include commercial sex acts).

## Index Crime

A crime for which reports of offenses committed are collected. Index crimes are murder, rape, robbery, aggravated assault, burglary, larceny/theft, motor vehicle theft, arson, and human trafficking.

## Intimidation

To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.

## Justifiable Homicide (Not a Crime)

The killing of a perpetrator of a serious criminal offense by a peace officer in the line of duty, or the killing, during the commission of a serious criminal offense, of the perpetrator by a private individual.

## Juvenile

In Texas, a juvenile is a person under 17 years of age (i.e., 16 years and under). At the federal level, Juvenile is a person under 18 years of age (i.e., 17 years and under). Unless otherwise indicated, this publication follows the state definition for juvenile.

## Kidnapping/Abduction

The unlawful seizure, transportation, and/or detention of a person against his/her will, or of a minor without the consent of his/her custodial parent(s) or legal guardian.

## Larceny/Theft

The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another. This includes pocket-picking, purse-snatching, shoplifting, theft from motor vehicles, theft of motor vehicle parts and accessories, theft of bicycles, theft from buildings and theft from coin-operated machines.

## Liquor Laws

State and/or local liquor law violations, except drunkenness and driving under the influence. Federal violations are excluded. This is a Group B offense and only arrest information is reported.

## Manslaughter by Negligence (Negligent Manslaughter)

The killing of another person through gross negligence. This offense includes killings resulting from hunting accidents, gun cleaning, children playing with guns, etc. It does not include deaths of persons due to their own negligence, accidental deaths not resulting from gross negligence, and accidental traffic fatalities. This offense does not include Vehicular Manslaughter, which are reported as Murder and Non-Negligent Manslaughter if not accidental or All Other Offenses if accidental.

## Motor Vehicle Theft

The theft or attempted theft of a motor vehicle, which is defined as a self-propelled vehicle that runs on land surface and not on rails.

## Murder and Non-Negligent Manslaughter

The willful (non-negligent) killing of one human being by another. This includes any death due to injuries received in a fight, argument, quarrel, assault, or commission of a crime. Suicides, accidental deaths, assaults not resulting in death, traffic fatalities, and attempted murders are not included.

## NIBRS

National Incident-Based Reporting System (NIBRS) is an incident-based reporting system or methodology used by law enforcement agencies in the United States for collecting and reporting data on crimes to the Federal UCR program. The FBI maintains the reporting guidelines.



## Non-Violent Crime

Non-violent crimes include property crimes which is broken down into burglary, larceny/theft, and motor vehicle theft offenses.

## Offenses against the Family and Children

Nonsupport, neglect, desertion, or abuse of family and children. Includes attempts.

## Other Assault (Simple)

An unlawful physical attack by one person upon another where neither the offender displays a weapon (other than personal weapon), nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

## Part One Offenses

The first of two categories of offenses (within the Crime Index) established for crime reporting purposes. Part one offenses are by their nature more serious and/or occur most frequently. The reports of these offenses committed are collected without regard to whether an arrest was made.

## Personal Weapon

The use of hands, feet, fists, and teeth as a weapon to commit a crime; also termed “strong-arm weapon.”

## Pornography/Obscene Material

The violation of laws or ordinances prohibiting the manufacture, publishing, sale, purchase, or possession of sexually explicit material, e.g., literature, photographs, etc.

## Prejudice

An unreasonable and unjustifiable negative attitude toward a group and its individual members.

## Prostitution and Commercialized Vice

Sex offenses of a commercialized nature, such as prostitution, keeping a bawdy house, procuring, transporting women for immoral purposes, etc. Includes attempts.

# Race

In UCR, race and ethnic origin are counted as two separate designations. The racial categories were adopted from the U.S. Department of Commerce and are as follows: White, Black or African American, American Indian or Alaskan Native, Asian, Native Hawaiian or Other Pacific Islander.

## White

A person having origins in any of the original peoples of Europe, North Africa, or the Middle East.

## Black or African American

A person having origins in any of the Black racial groups of Africa.

## American Indian or Alaskan Native

A person having origins in any of the original peoples of North and South America (including Central America), and who maintains tribal affiliation or community attachment.

## Asian

A person having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian subcontinent including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam.

## Native Hawaiian or Other Pacific Islander

A person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands, e.g., Individuals who are Carolinian, Fijian, Kosraean, Melanesian, Micronesian, Northern Mariana Islander, Palauan, Papua New Guinean, Ponapean (Pohnpelan), Polynesian, Solomon Islander, Tahitian, Tarawa Islander, Tokelauan, Tongan, Trukese (Chuukese), and Yapese.

# Rape

The penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim, including instances where the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental or physical incapacity.

# Robbery

The taking, or attempting to take, anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence and/or by putting the victim in fear of immediate harm.

# Sex Offenses (Except Rape, Prostitution and Commercialized Vice)

Any sexual act directed against another person, without the consent of the victim, including instances where the victim is incapable of giving consent.

## Summary Reporting (SRS)

SRS and its methodology had been a national method of collecting UCR statistics for the FBI since 1929. SRS collected basic statistical data and general tallies of offenses. The FBI elected to sunset SRS at the end of 2020, migrating to the more detailed NIBRS methodology.

## Part Two Offenses

The second of two categories of offenses (within the Crime Index) established for crime reporting purposes. Part two offenses are generally less serious in nature and/or occur less frequently than part one offenses. Monthly tabulations of part two offenses are limited to arrest information only.

## Vandalism/Destruction/Damage of Property

Willful or malicious destruction, injury, disfigurement, or defacement of any public or private property without the consent of the owner or person having custody or control of it. This excludes Arson.

## Weapons Law Violation

The violation of laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, concealment, or use of firearms, cutting instruments, explosives, incendiary devices, or other deadly weapons.
