# Pay raises top DPS legislative priorities

Pay raises for employees are listed as the highest funding priority outlined in the DPS Legislative Appropriations Request for this session.

The first "exceptional item" request is a salary increase for commissioned personnel and a 5 percent across the board salary increase for non-commissioned employees for each of the next two years.

Other funding requests include:

- Additional Special Crimes investigators and staff for counter terrorism and homeland security.
- Continued funding for the DL Re-engineering project, the Driver Responsibility Program and the Fraud Unit.
- Construction of a new Region VIII headquarters office building in Hidalgo County.
- Image Verification Technology (facial recognition) to enhance the driver license system to combat identity theft and DL fraud.
- Additional funding for the Private Security Bureau, including restoring funds lost when Private Security was integrated into the Department last session.
- A state-of-the-art driver training facility located near the firing range on the Florence property in Williamson County.
- Additional Crime Lab personnel and expenditures to keep up with the ever-increasing demand for case work.
  - Additional money to address current operating expense shortfalls.
- In-car computers for the Texas Highway Patrol Division to provide direct roadside messaging and communication to troopers on patrol using wireless technology.
- Funding for new buildings in Bryan, Pearsall, Waxahachie and a new crime lab facility in Garland, as well as expansions in Weatherford and at the San Antonio Babcock DL facility.
- Additional personnel for the Narcotics Service to assist in the oversight of various multi-jurisdictional task forces.
