# DPS trooper killed in crash

Highway Patrol trooper **Matthew Dewayne Myrick**, 36, died Friday, January 20 after losing control of his patrol unit while responding to a wreck south of Hereford.

As Myrick responded to the crash, he headed westbound on FM 1259 inside the Hereford city limits. He passed through the intersection of FM

1259 and Main Street and lost control of his vehicle. The patrol car went off the roadway, struck a concrete culvert, caught on fire and burned. Myrick died at the scene.

Trooper Myrick is the 80th DPS officer killed in the line of duty and the second to die this year.

Myrick was born in Clovis, New Mexico and graduated high school in Paris, Texas. He served a brief stint in the Navy and earned agriculture-related masters and bachelors degrees from Texas Tech University. He worked in agriculture industry over the years,



but always wanted to be a state trooper.

He started with DPS in October 2003, graduated from the DPS Academy April 2004 and was assigned to Highway Patrol in Hereford.

"Trooper Myrick was known as a man devoted to his wife, four children and his church, said DPS Director Col. **Thomas Davis Jr.** "We were honored to have him as part of our family. And he will always be remembered as a man who gave his life serving the people of Texas. Make sure that his family is in your thoughts and prayers."

Myrick is survived by his wife, Christy, and four children: 7-year-old Matilyn, 5-year-old Tate, 2-year-old Luke and 3-month old Embry.

Dear Fellow Employee,

As many of you are probably aware, the Texas Legislature last session mandated that all Schedule C commissioned officers must meet minimum fitness standards by Sept. 1, 2006 in order to receive promotions or pay increases. DPS has hired Fitness Intervention Technologies to develop minimum physical fitness standards for commissioned officers. We expect that the company will present its report by May 31.
