# Major crime rate drops in 2006

The major crime rate in Texas decreased 5.3 percent in 2006, according to data compiled by our Uniform Crime Reporting Program.

Compared with 2005, the crime rate—the number of crimes per 100,000 population in Texas—dropped 5.3 percent in 2006. The violent crime rate decreased 2.3 percent in 2006 from 2005. The property crime rate fell 5.7 percent in 2006.

DPS Director Col. **Thomas A. Davis Jr**. noted, "The crime rate has declined four straight years thanks to the efforts of our citizens and the law enforcement community. While this is encouraging, there is still much work to be done."

The total number of major crimes committed was down 2.6 percent in 2006 compared with 2005. Of the seven index crimes, murder was down 1.4 percent; rape was down 1.2 percent.

The total number of arrests in Texas increased 2.9 percent in 2006. The number of juvenile arrests decreased 0.7 percent, while adult arrests increased 3.5 percent.

The Texas Uniform Crime Reporting Program also collects statistics on hate crimes and family violence incidents. In 2006, Texas law enforcement agencies reported 247 incidents of hate crimes involving 222 victims and 291 offenders. Law enforcement agencies reported 186,868 family violence incidents involving 200,803 victims and 197,037 offenders in 2006.

# Roadcheck 2007 hits the road

DPS troopers and inspectors will participate in the international Roadcheck 2007, a 72-hour intensive inspection program that runs from June 5 through 7 throughout North America.

Commercial Vehicle Enforcement troopers and noncommissioned inspectors, along with Highway Patrol troopers who have received specialized training in commercial vehicle inspection, will stop thousands of commercial vehicles to inspect safety equipment and check driver log books, driver licenses and endorsements. Inspectors will also look for possible drug or alcohol use.

The Roadcheck program, which stretches from Mexico to Canada, is designed to reduce commercial vehicle highway fatalities through increased vehicle safety.

# Drug bust makes record book

DPS troopers seized nearly fourand-a-half tons of marijuana April 9 after stopping a tanker truck in Jim Hogg County on Highway 285 near Hebbronville. The 8,932 pounds of marijuana was worth at least \$4.5 million. David Nevarez, CVE Hebbronville, made the stop after Oziel Garza, HP Hebbronville, received intelligence about a suspicious commercial vehicle. It may be the second largest marijuana seizure during a routine traffic stop in DPS history. The all-time record was 11,921 pounds seized in Bee County in 2004.
