**This form is an application for a cash transaction card and cannot be used as the Cash Transaction Card issued by the MRE, per <u>Texas Occupations</u> <u>Code §1956.038(a-1)</u> and §1956.0382(c).

Cash Transaction Card – Texas Occupations Code §1956.0382(g) A metal recycling entity shall preserve: (1) Each application for a cash transaction card the entity receives until the second anniversary of the date the application was received.

False Identification or False Information - It is a criminal offense to knowingly provide false identification or false information to an MRE with the intent to deceive, per Texas Occupations Code §1956.038(a) and §1956.040(a).

Tampering with a Government Record - A person commits an offense if he/she knowingly makes a false entry in, or false alteration of, a governmental record, per <u>Texas Penal Code §37.10</u>.

Renewal Application – Texas Occupations Code §1956.035 requires the renewal application be kept on file with the original cash transaction card application, and be available for inspection by law enforcement.
