1 Executive Summary

This report is provided by the Regulatory Services Division (RSD) of the Texas Department of Public Safety (DPS) in accordance with the requirements outlined in House Bill 1927 (Government Code, Section 411.02096), 87th Regular Session of the Texas Legislature, 2021.

The report is to include information related to the carrying of firearms by persons in this state, including information specific to the License to Carry (LTC) program and any other relevant information related to the carrying of firearms in Texas.

The Regulatory Services Division licenses individuals to carry handguns within Texas, evaluates the eligibility of applicants through criminal history background checks, and monitors those currently licensed to ensure their continued eligibility.

The DPS Crime Records Division maintains various programs that collect information submitted by local criminal justice agencies throughout the state. Submitted information is compiled into statewide databases or systems and forwarded to national criminal justice databases at the Federal Bureau of Investigation (FBI).

2 Definitions

The reports provide data based on calendar year.

2.1 Regulatory Service Reports

I Applications Received

The number of paid original and renewal applications received during the reporting period.

II Licenses Issued

The number of original and renewal licenses issued during the reporting period.

III Average LTC applications 2010-2025

The total number of original and renewal applications received in the current year compared to the average from 2010-2025

2.2 Crime Records Reports

The number of arrests and convictions reported to the department during the specified year. These are grouped by offense codes.

I Arrest

Arrest data indicates the year of the arrest, which may not be the year in which the outcome is determined.

II Conviction

Conviction data indicates the year in which the conviction was finalized, which may not be the year in which the arrest originally occurred.

III Offense Codes


Offense codes are grouped by three broad categories:


3.1 Application Payments Received

The following graph outlines the total amount of paid Handgun License applications received by DPS for the calendar years 2010-2025. The chart shows the number of original, and renewal paid applications.




3.2 Licenses Issued

The following graph outlines the total amount of Handgun Licenses issued by DPS for the calendar years 2010-2025. The chart indicates the number of original and renewed licenses issued.






4.1 Arrests
