Agency/User Accounts

Agency/user access forms for each Track-Kit user group, including prosecutors, are available on the [SAE Tracking](#) website under **User Access Forms**. These forms are used to establish agencies and populate user information in Track-Kit.

SAE Collection Kit Update

Both Sirchie and Tri-Tech are projecting shipments of the new Texas Sexual Assault Evidence Collection kits to begin the last week of September. Both manufacturers will be utilizing the Kit Manufacturer/Distributor Portal in Track-Kit.

Barcodes/Cards for Uncollected Kits

If your hospital/agency/lab currently has uncollected sexual assault evidence kits in your inventory without tracking barcodes, DPS will provide a tracking barcode and the survivor card for use on kits collected after September 1st. Send requests for barcodes/survivor cards to the SAE Tracking Program by email at kittracking@dps.texas.gov. Please include with your request a contact person, mailing address, phone number, and the approximate number of uncollected kits without barcodes.

If you receive a kit that does not contain a barcode and it was collected on or after September 1st, please contact DPS and we will email you a barcode and survivor card for the kit.

Track-Kit Refresher Training

STACS DNA will continue to provide web-based training sessions for each user group. During these 30 minute - 1 hour web-based training sessions, users will receive instruction in order to successfully track evidence through the system. Users only need to participate in one session. These webinar sessions will be recorded and available for users to review within the Help Center in Track-Kit.
