## Overview

This Technical Specification is a guide for vendors and law enforcement agencies who electronically submit Uniform Crime Reporting data via NIBRS guidelines.

Since the Department has developed their system to closely match the national program, we have instead focused on a document that is truly "Texas Centric". This Technical Specification is intended to be an addendum to the FBI User Manual Technical Specifications, specifically designed for Texas data and Texas law enforcement.

For Data Quality purposes, DPS has added Texas Specific validations that supersede the NIBRS guidelines. These validations will be preceded by T-XXX. (e.g. T-221)

The data captured in Segment Levels 8 & 9 is not forwarded to the FBI but is published in the annual Crime in Texas publication.

## Segment Levels 8 & 9 – Additional Texas Data Elements

### When to Submit Segment Levels 8 and 9

**Segment Level 8** should be submitted as part of a complete incident under the following circumstances:

1. when the incident involves Crimes Against Person or Robbery and familial relationship(s)
2. when there are more than three types of drugs involved in a drug seizure case
3. when marijuana plants were seized from a garden, wild field, cultivated field, or greenhouse
4. when clandestine labs or precursor chemicals were seized as part of an incident.

**Segment Level 9** should be submitted as part of a complete incident under the following circumstances:

1. when the incident involves a sexual assault.
2. when the offense is related to one of the following six mandated Texas Penal Codes:
  - 1) Continuous Sexual Abuse of Young Child or Children
  - 2) Indecency with a Child by Contact
  - 3) Indecency with a Child by Exposure
  - 4) Sexual Assault
  - 5) Aggravated Sexual Assault
  - 6) Sexual Performance by a Child

## Family Violence

### Texas Government Code

#### Sec. 411.042. BUREAU OF IDENTIFICATION AND RECORDS

(b) The bureau of identification and records shall:

(2) collect information concerning the number and nature of offenses reported or known to have been committed in the state and the legal steps taken in connection with the offenses, and other information useful in the study of crime and the administration of justice, including information that enables the bureau to create a statistical breakdown of: (A) offenses in which family violence was involved

### Submission Requirements

An incident should be flagged as family violence when the incident involves Crimes against Person or Robbery, and at least one of the relationships of the victim to offender is:

SE = Victim was Spouse	IL = Victim was In-Law
CS = Victim was Common-Law Spouse	SP = Victim was Stepparent
PA = Victim was Parent	SC = Victim was Stepchild
SB = Victim was Sibling (Brother or Sister)	SS = Victim was Stepsibling
CH = Victim was Child	XS = Victim was Ex-Spouse
OF = Victim was Other Family Member	GC = Victim was Grandchild
GP = Victim was Grandparent	XR = Ex-Relationship (Ex-boyfriend/girlfriend)
BG = Victim was Boyfriend/Girlfriend	

\*OK = Victim was Otherwise Known (e.g., Roommates)

### Segment Level 8 – Data Elements and Values (Family Violence)

Character spaces 001-004 define the Segment Length and 005 define the Segment Level. From character space 006-037 of Segment Level 8 correspond to the same character spaces for each of the six levels associated with a Group “A” Incident. A description of the additional data elements specific to Family Violence are as follows:

**Incident Date** - 8 characters; 038-045: Enter the date of the incident in the proper format (YYYYMMDD).

**Family Violence Indicator** - 1 character; 046: Enter “Y” to indicate family violence occurred in this incident.

\*When using relationship code OK, you must indicate a “Y” or “N” for family violence, as this relationship code can be familial or non-familial.

## Drug Seizures

### Texas Health and Safety Code Sec. 481.185. ARREST REPORTS

(a) Each law enforcement agency in this state shall file monthly with the director a report of all arrests made for drug offenses and quantities of controlled substances seized during the preceding month. The agency shall make the report on a form provided by the director and shall provide the information required by the form.

(b) The director shall publish an annual summary of all drug arrests and controlled substances seized in the state.

### Submission Requirements

The national NIBRS program collects information on up to three different types of drug seized within a single incident.

Segment Level 8 must be submitted for drug seizure if it meets one of the following criteria:

1. When more than three types of drugs are involved, the type of measurement for the two most important drugs (as determined by the reporting agency based on the quantity, value, and deadliness of the drugs/narcotics) should be reported in Segment Level 3 Measurement Type 1 and Measurement Type 2; Measurement Type 3 enter X = Over Three Drug Types. Up to an additional seventeen drug types can be captured in Segment Level 8.
2. If three or fewer types of drugs are seized and one of the drugs is marijuana in a garden, fields, greenhouse, and/or clandestine labs or precursor chemicals were seized as part of an incident then enter the estimated quantity and type of drug measurement in Segment Level 3. In addition, submit Segment Level 8 with data for Marijuana fields, garden, or greenhouse; clandestine labs; and/or precursor chemicals.

### Segment Level 8 – Data Elements and Values (Drug Seizures)

**Suspected Drug Type** – 1 character; 047: This data element is to be used to identify the types of drugs or narcotics seized in an incident. This field is used when the types of drugs seized exceeds three (submitted in Segment Level 3).

Example: If one of the offenses in the incident was 35A = Drug/Narcotic Violation, 6 = Seized was entered into Data Element 14 (Type Property Loss/Etc.), and 10 = Drugs/Narcotics was entered into Data Element 15 (Property Description) and more than three drugs were involved, enter the two most important (as determined by quantity, value, and deadliness of the drugs/narcotics) in Segment Level 3, and enter X = More than Three Drug Types in the third occurrence in Data Element 20. No quantity indicator is required for the “Over Three Drug Types” category. Enter the remaining drugs in Segment Level 8.

Valid data values for types of drugs/narcotics for reporting are:

- A = "Crack" cocaine
- B = Cocaine – all forms except "Crack"
- C = Hashish
- D = Heroin
- E = Marijuana (including THC)
- F = Morphine
- G = Opium
- H = Other Narcotics – Codeine; Demerol; Dihydromorphinone or Dilaudid; Hydrocodone or Percodan; Methadone, Buprenorphine (Naloxone), Desomorphine (Permonid), etc.
- I = LSD
- J = PCP
- K = Other Hallucinogens – BMDA or "White Acid"; DMT; MDA; MDMA; Mescaline or Peyote; Psilocybin STP; Spice, K2, etc.
- L = Amphetamines/Methamphetamines
- M = Other Stimulants – Adipex, Fastine, and Ionamin (Derivatives of Phentermine); Benzedrine; Didrex; Methylphenidate or Ritalin; Phenmetrazine or Preludin; Tenuate; Bath Salts, Khat, etc.
- N = Barbiturates
- O = Other Depressants – Glutethimide or Doriden; Methaqualone or Quaalude; Pentazocine or Talwin; etc.
- P = Other Drugs – Antidepressants, i.e., Elavil, Triavil, Tofranil, etc; Aromatic Hydrocarbons; Propoxyphene or Darvon; Tranquilizers, i.e., Chlordiazepoxide or Librium, Diazepam or Valium, etc. (Including Synthetic Narcotics such as Fentanyl)
- U = Unknown type
- X = More than three (3) drug types (can only be used in NIBRS Segment Level 3 in the third occurrence of Data Element 20)

**Estimated Drug Quantity** – 12 characters; 048-059: This data element is used to indicate the quantity of drugs or narcotics seized in an incident. The left-most 9 characters are for the whole number of pounds, ounces, etc. The right 3 characters are for decimal values.

If the substance was sent to a laboratory for analysis and a response has not yet been received, 1 = None should be entered into Data Element 21 (Estimated Drug Quantity). When the agency receives the results of the laboratory analysis, the agency must update Data Elements 21 (Estimated Drug Quantity) and 22 (Type Drug Measurement).

Example: 000000001000

**Type Drug Measurement** – 2 characters; 060-061: This data element is used to indicate the type of measurement in quantifying drugs or narcotics seized in a drug case. It is used only if one of the offenses in an incident was 35A = Drug/Narcotic Violation, 6 = Seized was entered into Data Element 14 (Type Property Loss/Etc.), and 10 = Drugs/Narcotics was entered into Data Element 15 (Property Description) and more than three drugs were involved.

If the substance was sent to a laboratory for analysis and a response has not yet been received, XX = Not Reported should be entered. When the agency receives the results of the laboratory analysis, the agency must update Data Elements 21 (Estimated Drug Quantity) and 22 (Type Drug Measurement).  
Valid Data Values:

**Note:** Up to seventeen entries are allowed for the type, quantity, and measurement for drugs seized. Entries should be made in the lowest numbered occurrence.

**Type Marijuana Fields and Gardens** – 1 character; 257. This field is used when marijuana seized was in a garden, wild field, cultivated field, or greenhouse.

Valid Data Values:

- 1 = Gardens
- 2 = Wild Fields
- 3 = Cultivated Fields
- 4 = Greenhouses

**Number Marijuana Fields and Gardens/Items** – 1 character; 258. This field is used to indicate the number of Gardens, Wild Fields, Cultivated Fields, or Greenhouses that were seized. The valid values are 1-9. If there was no seizure of marijuana fields and gardens, leave blank.

Example: if marijuana in two greenhouses were seized, 4 = Greenhouses would be entered in Type Marijuana Fields and Gardens and “2” would be entered to indicate the number of greenhouses.

**Type of Drug Manufactured and Number of Clandestine Labs Seized** – 1 character: 259-264. This data element is used to indicate the type of drug manufactured and number of clandestine labs seized in an incident. The valid values are 1-9 for each lab seized. If there were no lab seizures, leave blank. Enter total lab seized for each drug type in appropriate data field.

<u>Data Field</u>	<u>Drug Type</u>
259 =	Methamphetamine
260 =	Amphetamines
261 =	P2P – Phenylacetone
262 =	PCP – Phencyclidine
263 =	“Crack” cocaine
264 =	Other (Controlled Substances)



**Quantity of Precursor Chemical Seized** – 7 characters; 265-271: Estimate the quantity of the precursor chemical seized. Enter a whole number value only. If fractional values are involved, round up to the nearest whole number.

**Type Measurement for Precursor Chemical** – 2 characters; 272-273: This data element is used when Quantity of Precursor Chemical Seized is a non-blank value. Valid entries are:

WEIGHT

GM = Gram

KG = Kilogram

OZ = Ounce

LB = Pound

CAPACITY

ML = Milliliter

LT = Liter

FO = Fluid Ounce

GL = Gallon

**Note:** Up to six entries are allowed for the quantity and type measurement for precursor chemicals. Entries should be made in the lowest numbered occurrence.

Example: if three precursor chemicals are seized, information on these chemicals should be forwarded in occurrences 1, 2, and 3 of this data element. Occurrences 4, 5 and 6 should be blank.

The multiple occurrences of data Elements T8 (Drug Seizures) Characters 265-318 are to allow for seized precursor chemicals that are measured in different units.

Example: if one chemical is measured in pounds and another one is measured in liters, then two occurrences would be needed to report this information. However, if two chemicals are seized and both are measured in pounds, combine the quantities and report the amount in the first occurrence in characters 265-273.

# Sexual Assault

## Texas Government Code

### Sec. 411.042. BUREAU OF IDENTIFICATION AND RECORDS

(h) Information collected to perform a statistical breakdown of offenses under Sections 22.011 and 22.021, Penal Code, as required by Subsection (b)(2) must include information indicating the specific offense committed and information regarding:

- (1) the victim;
- (2) the offender and the offender's relationship to the victim;
- (3) any weapons used or exhibited in the commission of the offense; and
- (4) any injuries sustained by the victim.

(i) A law enforcement agency shall report offenses under Section 22.011 or 22.021, Penal Code, to the department in the form and manner and at regular intervals as prescribed by rules adopted by the department. The report must include the information described by Subsection (h).

### Submission Requirements

Segment Level 9 must be submitted when the incident involves sex offenses.

The types of Sexual Assault offenses to be reported are limited. This data collection will collect information on six specific Texas penal code offenses under Section 22.011 or 22.021.

1. Continuous Sexual Abuse of Young Child or Children
2. Indecency with a Child by Contact
3. Indecency with a Child by Exposure
4. Sexual Assault
5. Aggravated Sexual Assault
6. Sexual Performance by a Child

### Segment Level 9 – Data Elements and Values (Sexual Assault)

Character spaces 001-004 define the Segment Length and 005 define the Segment Level. From character space 006-037 of Segment Level 9 correspond to the same character spaces for each of the six levels associated with a Group "A" Incident. A description of the additional data elements specific to Sexual Assault are as follows:

**Incident Date** – 8 characters; 038-045: Enter the date of the incident in the proper format (YYYYMMDD).

**Victim Sequence Number** – 3 characters; 046-048: Left zero fill up to 001-999. Cannot be blank.

**Offender Sequence Number** – 2 characters; 049-050: Left zero fill up to 01-99. 00 = Unknown Offender

**Offense (Penal Codes)** – 1 character; 051-056:

Valid Data Values:

- 051 / 1 = Continuous Sexual Abuse of Young Child or Children
- 052 / 2 = Indecency with a Child by Contact
- 053 / 3 = Indecency with a Child by Exposure
- 054 / 4 = Sexual Assault
- 055 / 5 = Aggravated Sexual Assault
- 056 / 6 = Sexual Performance by a Child

NIBRS codes should be programmed to the appropriate Texas Penal codes.

FBI NIBRS codes 11A - 11C should always be reported with a segment 9.

FBI NIBRS codes 11D, 370, and 90C are conditionally reported with a segment 9, if any offense meets the Texas Penal code criteria.

- a) 11D = Fondling related to Indecency with a child by contact.
- b) 370 = Pornography related to Sexual Performance by a Child.
- c) 90C = Disorderly Conduct related to Indecency with a Child by Exposure.

90C is a Group B offense and is only reported in the NIBRS segments when there is an arrest. However, if the offense relates to Indecency with a Child by Exposure, then it needs to be reported in Segment 9, even without an arrest.

In some cases, this offense could be reported in Segment 9 without any NIBRS incident information (segments 1-7).

\*Per Texas penal code "Child" means a person younger than 17 years of age.

Two additional Texas Penal Codes will be added to the Segment 9 collection towards the end of the year, as DPS updates our UCR Repository.

- More information on those offense codes and reporting guidelines will be sent once the technical details are finalized.

## **Conditional Data Element and Values**

If offense is related to either of the following penal codes:

- 3 = Indecency with a Child by Exposure
- 6 = Sexual Performance by a Child

Characters 057-092 are required. For all other penal codes these characters must be blank.

**Arrest Transaction Number (ATN)** – 12 characters; 057-068. The ATN must follow the NIBRS guidelines when an arrest is reported for these penal codes. If there is no arrest these characters must be blank.

**Arrest Sequence Number** – 2 characters; 069-070. The Sequence Number must follow the NIBRS guidelines when an arrest is reported for these penal codes and when an ATN is present it cannot be blank. If there is no arrest these characters must be blank.

**Victim Age** – 2 characters; 071-072. Victim Age must be one of the following valid entries:

01-99

NB = Newborn - less than a week old

BB = Baby - more than a week but less than a year old

00 = Unknown

**Note:** Data Element 26 (victim age) any combination of years 01-99 is valid for an age range. The youngest age in the range must be listed as the age for that victim in Segment 9. Example: For Data Element 26 (victim age) “2530” is a valid age range. This would be entered as “25” for victim age in Segment 9.

**Victim Sex** – 1 character; 073. Victim Sex must be one of the following valid entries:

0=Unknown

1= Male

2= Female

**Victim Race** – 1 character; 074. Victim Race must be one of the following valid entries:

0= Unknown

1= White

2= Black/African American

3= American Indian/Alaskan Native

4= Asian

5= Native Hawaiian or Other Pacific Islander

**Victim Ethnicity** (Optional) – 1 character; 075. Victim Ethnicity must be one of the following valid entries if reported:

0= Unknown

1= Hispanic or Latino

2= Not Hispanic or Latino

If not reported should be blank.

**Offender Age** – 2 characters; 076-077. Offender Age must be one of the following valid entries:

01-99

00 = Unknown

**Note:** Data Element 37 (offender age) any combination of years 01-99 is valid for an age range. The youngest age in the range must be listed as the age for that offender in Segment 9. Example: For Data Element 37 (offender age) “2530” is a valid age range. This would be entered as “25” for offender age in Segment 9.

**Offender Sex** – 1 character; 078. Victim Sex must be one of the following valid entries:

0=Unknown

1= Male

2= Female

**Offender Race** – 1 character; 079. Victim Race must be one of the following valid entries:

- 0= Unknown
- 1= White
- 2= Black/African American
- 3= American Indian/Alaskan Native
- 4= Asian
- 5= Native Hawaiian or Other Pacific Islander

**Offender Ethnicity** (Optional) – 1 character; 080. Victim Ethnicity must be one of the following valid entries if reported:

- 0= Unknown
- 1= Hispanic or Latino
- 2= Not Hispanic or Latino

If not reported should be blank.

**Offense Relationship (Victim to Offender)** – 2 characters; 081-082.

**Offense Weapon** – 1 character per weapon; 083-085. Left justified and up to 3 unique weapon types can be filled.

Valid Entries:

- 1 = Firearm
- 2 = Knife/Cutting Instrument
- 3 = Blunt Object (club, baseball bat, pan, etc.)
- 4 = Personal Weapons (hands, feet, fist, teeth, etc.)
- 5 = Drugs/Narcotics/Sleeping Pills
- 6 = Asphyxiation (strangulation, suffocation, etc.)
- 7 = Other Specify

Note: Sexual Assault Report only allows the 7 weapon codes. For converting NIBRS weapon codes, we provided the conversion table below.

- N = None
- M = Apparent Minor Injury
- B = Apparent Broken Bones
- I = Possible Internal Injury
- L = Severe Laceration
- O = Other Major Injury
- T = Loss of Teeth
- U = Unconsciousness

**Note:** Sexual Assault Report allows the NIBRS Injury codes. These codes will be converted to the Sexual Assault Report Injury codes for the Sexual Assault Report; we provided the conversion table below. 1=None is mutually exclusive.

**Incident Hour** – 2 characters; 087-088. Left justified Standard military time used to identify the hour of the incident. If the hour is unknown, leave blank.

Valid Entries:

00-23

**Offense Location** – 2 characters; 089-090.

**Note:** NIBRS location codes will be converted to the Sexual Assault Report Location codes for the Sexual Assault Report; we provided the conversion table below.

The information cannot be different.
- 958 All Offenders must be related to each Victim for Segment 9 Sexual Assault
